NARRATIVE

On Tuesday, May 31st, 2022, at approximately 1312 hours, I was dispatched to 6207 West Price Blvd (The Morgan Center) in reference to a battery.

Upon arrival, I met the complainant, Shelby Mendelson. Shelby advised that at approximately 1230 hours, a juvenile identified as, [REDACTED] hereinafter referred to as the victim, reported that he got punched after an argument over a game call. The victim showed obvious signs of injury to the nose area. Through investigative means, The Morgan staff were able to identify the second juvenile as, [REDACTED] hereinafter referred to as the defendant. The

victim's mother [REDACTED] responded to the Morgan center [REDACTED] filled out an injury report and advised she was taking the victim to see a doctor.

I observed a [REDACTED] [REDACTED] The defendant and the victim are seen playing basketball on the inside court. The defendant is seen walking next to the victim and exchanging some words. The defendant then throws a punch toward the victim's face and appears to make contact. I took a video with my work-issued phone and the video was submitted to evidence.com. Shelby stated that she wanted the defendant trespasses from the premises.

I spoke with [REDACTED] at her residence. [REDACTED] opted to not pursue charges for battery at this time and signed a complaint withdrawal. [REDACTED] said that it was ok to provide her phone number to the defendant's parents so that they can discuss this incident. [REDACTED] received Marsy's law paperwork.

I spoke with the defendant's father [REDACTED] [REDACTED] advised that the defendant was not home. I informed [REDACTED] of the incident and he advised that he will speak with the defendant as this is not the first time an incident like this occurred. [REDACTED] positively identified the defendant as his son. [REDACTED] accepted and signed Form #126 (City property trespass) for his son and was advised of the repercussions of violating the trespass [REDACTED] said that he will not contest it.

All paperwork was forwarded to the records department. This crime occurred within the city of North Port, Sarasota County FL.


