3. PUBLIC HEARINGS:

ORDINANCE:

ORD NO. 2022-11

An Emergency Ordinance of the City of North Port, Florida, Amending the Effective Date of Ordinance No. 2021-46, Regarding Tree Protection Regulations; Providing for Findings; Providing for Conflicts; Providing for Severability; and Providing an Effective Date.

Mayor Emrich announced the item and directed the City Clerk to read the Ordinance in its entirety.

Ms. Taylor read the Ordinance in its entirety.

Mr. Fletcher introduced the item.

Ms. Slayton explained the voting process and the effects of the vote.

Discussion took place regarding concerns with delaying the effective date, stipulations for emergency Ordinances, concerns on time constraints, clear cutting being an unsustainable practice, contracts signed prior to Ordinance approval, fiscal responsibility, building permit process misconceptions, current permit application review, septic tank permit impacts, applications submitted prior to April 8, 2022, preparedness of staff, legality of the meeting, Special Meeting vs. Emergency Meeting, staff diligence, complexities of implementing the Ordinance, building permit process, and impact of delay on homeowners and private home builders.

Harry Taylor: willingness to pay fines and fees for removing protected and heritage trees.

Victor Dobrin: Ukrainian residents and expressed opposition in delaying the Tree Ordinance effective date.

Mayor Emrich closed the public hearing and requested a motion.

A motion was made by Commissioner McDowell, seconded by Commissioner Luke, to approve Ordinance No. 2022-11 as presented. The motion failed on the following vote:

Yes: 3 - Vice Mayor Langdon, Commissioner Luke and Commissioner McDowell

No: 2 - Mayor Emrich and Commissioner White

Commissioner White dissented due to the need to start with implementing the Ordinance and staff input regarding working out concerns.

Mayor Emrich dissented due to staff completion of the Ordinance, their ability to move forward and in the interest of tree protection, and citizen input.
