### ORDINANCE NO. 2016-25

**(Renaming North Main Street to Rue Berryman Street)**

**AN ORDINANCE OF THE CITY OF NORTH PORT, FLORIDA CHANGING THE NAME OF NORTH MAIN STREET TO RUE S. BERRYMAN STREET LOCATED IN THE CITY OF NORTH PORT, FLORIDA, BEGINNING FROM THE INTERSECTION AT CITY HALL BOULEVARD TO ITS TERMINUS AT THE INTERSECTION OF CITY CENTER BOULEVARD; PROVIDING FOR RENAMING OF STREETS; PROVIDING FOR A CHANGE OF THE OFFICIAL CITY MAP; PROVIDING FOR CHANGE TO STREET SIGNS; PROVIDING FOR RESCINDING RESOLUTION 2011-R-39, A RESOLUTION CEREMONIOUSLY RENAMING GREENWOOD AVENUE TO THE RUE S. BERRYMAN MEMORIAL ROADWAY; PROVIDING FOR FINDINGS; PROVIDING FOR ADOPTION; PROVIDING FOR SEVERABILITY; PROVIDING FOR CONFLICTS; AND PROVIDING FOR AN EFFECTIVE DATE.**

WHEREAS, The City of North Port has broad home rule powers granted by the Florida Constitution to enact ordinances which are not inconsistent with general or special law for the purposes of protecting the public health, safety, and welfare of its citizens; and

WHEREAS, The City Commission has determined that it is desirable to rename North Main Street to Rue S. Berryman Street and rescind the ceremonial naming of Greenwood Avenue.

**NOW, THEREFORE, BE IT RESOLVED BY THE CITY COMMISSION OF THE CITY OF NORTH PORT, FLORIDA, AS FOLLOWS:**

**SECTION 1 - RENAMING OF STREETS:**

- 1.01 A street name change is made for the length of North Main Street beginning from the intersection at City Hall Boulevard to its terminus at the intersection of City Center Boulevard as noted and depicted in Exhibit "A" attached hereto and incorporated herein by reference, and the name is hereby changed to "Rue S. Berryman Street".
- 1.02 The City of North Port Administrative Code, Article III. – Street Naming and Property Numbering, Sec. 70-56. (h)(6) b. provides that "similarity and duplication of names shall be avoided."
- 1.03 The proposed street name has been acknowledged by the North Port City Commission and will be provided to all affected property owners.
- 1.04 The City of North Port rescinds Resolution 2011-R-39 ceremoniously renaming Greenwood Avenue to the Rue S. Berryman Memorial Roadway.

**SECTION 2 - CHANGE TO THE OFFICIAL MAP:**

- 2.01 The City Clerk, being the custodian of the Official City Map, is hereby directed to cause these changes thereon.
- 2.02 The Neighborhood Development Services Department is hereby directed to contact all pertinent organizations and departments, notifying them of these changes of street names on the Official City Map.

**SECTION 3 - PROVIDING FOR A CHANGE TO STREET SIGNS:**

- 3.01 The Public Works Department, being the maintainer of street signs within the City of North Port, shall be notified of said changes, and immediately upon adoption of this ordinance shall therefore cause the name on all signs along North Main Street to be changed to Rue S. Berryman Street and remove ceremonial signs along Greenwood Avenue.

**SECTION 4 - FINDINGS:**

- 4.01 After consideration, the City Commission, at its regularly scheduled meetings of Tuesday, July 12, 2016, and Tuesday, July 26, 2016 found that the renaming of North Main Street to Rue S. Berryman Street will not affect the health, safety, welfare or convenience the citizens of the City of North Port or the City itself, and voted to approve the renaming of North Main Street.

SECTION 5 - ADOPTION:

5.01 The North Port City Commission hereby approves and adopts the following proposed street name change from North Main Street to Rue S. Berryman Street, which is attached hereto as "Exhibit A".

SECTION 6 - SEVERABILITY:

6.01 If any section, subsection, sentence, clause, phrase or portion of this Ordinance is held invalid or unconstitutional by any court of competent jurisdiction; such portion shall be deemed a separate, distinct, and independent provision and such holding shall not affect the validity of the remaining portion thereof.

SECTION 7 - CONFLICTS:

7.01 In the event of any conflict between the provision of this Ordinance and any other Ordinance or portions thereof, the provisions of this Ordinance shall prevail to the extent of such conflict.


SECTION 8 - EFFECTIVE DATE:

8.01 This Ordinance and the provisions thereof shall take effect immediately upon adoption by the City Commission.


