The North Port Police Department would like to continue our partnership with IPTM and FDOT to improve pedestrian and bicyclist safety in our jurisdiction under the High Visibility Enforcement (HVE) Pedestrian and Bicycle Safety Project.

For the 2022/2023 HVE campaign, our department is requesting \$8,433.41 to provide high visibility enforcement operations in areas with a high rate of pedestrian/bicycle crashes. A section of Tamiami Trail, from Tuscola Blvd to our border with Charlotte County and Petronia Street to North Waconia Street along West Price Blvd has been identified. This operation would provide enforcement and education for pedestrians, bicyclist and motorist that will increase compliance with traffic statutes and keep our citizens safe.

North Port Police Department High Visibility Enforcement (HVE) Strategic Operational Plan/Summary

Mission:

To educate the public and pedestrians as well as motorists in regard to Florida laws and potential violations for illegal crossings of surface streets. Mission is to make citizen contacts with those who travel on foot as well as those who drive in the designated HVE areas.

Goals:

- To establish a sustainable decrease in crash fatalities
- To increase traffic safety awareness by the public
- To improve public education through increased citizen contacts with law enforcement

Objectives:

• To educate, enforce, eliminate pedestrian and vehicular violations as well as serious injury accidents by illegal street crossings.

Operational Synopsis:

The City of North Port has partnered with the University of North Florida to establish guidelines and educate the community about high visibility enforcement in designated areas. This partnership will occur in three designated stages:

- Stage one will consist of education through curriculum, education material, and citizen contacts.
- Stage two will consist of citizen contact, education and written warnings.
- Stage three will consist of enforcement through citations. This will be the final stage.

All designates stages will be staffed by HVE contract approved officers who are off duty Specific strategies to be used will include:

- Traffic message boards to advise and educate the public affected.
- Marked Vehicle enforcement, motorcycle enforcement and foot patrols.

Personnel:

HVE Operations will utilize as much personnel as possible to accomplish the designates objectives that support the goals of this operation. The operation will utilize, but will not be limited to the following staff:

Scheduling:

This operation will be conducted for a minimum period of two months. The scheduled times will vary throughout the campaign. Scheduled personnel will monitor, educate, warn and enforce the laws of the State of Florida.
