NARRATIVE

On 05/02/2022 at approximately 1613 hours, I was dispatched to the Morgan Family Community Center, 6207 W Price Blvd, North Port, FL, in response to a Disturbance call for service (CFS). The caller, later identified as Samantha Cremen, contacted the NPPD Dispatch and advised there were two black males (unknown age) who were in a verbal argument and she believed it would become physical.

I arrived at approximately 1621 hours and discovered other units had already identified the male who caused the disturbance as Dale Binns. Officer Fegan explained to Dale he was trespass

warned from the premises for one year (until 05/02/2023) and could be subject to arrest if he returned, to which he stated he understood and departed prior to receiving his copy of the Written Notice of Public Property Trespass Warning (NPPD-126).

I contacted Tricia Wisner, the Assistant Director and authorized person, who confirmed she requested Dale be trespass warned for violating City Ordinance 46-1(a)(9) - Use of insulting or fighting words which by their very utterance inflict injury or tend to incite a breach of the peace. I completed the NPPD-126 form, which Tricia signed, and departed the facility.

I then met with Dale at his residence (3027 Idlewood St, North Port, FL), and provided him with his copy of the NPPD-126 form, which he signed freely and of his own volition. I explained Dale's options to him, to include how to appeal the trespass, to which he stated he understood. I departed Dale's home without incident.

I added a trespass warning flag to Dale's electronic profile within RMS and submitted the NPPD-126 form into Records, ending my involvement with the CFS.
