NOTICE IS HEREBY GIVEN, that on Tuesday, June 21, 2022, at 6:00 p.m. or shortly thereafter, Ordinance No. 2022-03 will be read for second reading in the City Commission Chambers located at City Hall, 4970 City Hall Boulevard, North Port, Florida.

ORDINANCE NO. 2022-03

AN ORDINANCE OF THE CITY OF NORTH PORT, FLORIDA, AMENDING THE CODE OF THE CITY OF NORTH PORT, FLORIDA, CHAPTER 58 – PLANNING AND DEVELOPMENT, ARTICLE III. – IMPACT FEES AND UPDATING IMPACT FEE RATE SCHEDULES FOR THE CITY'S PARKS, FIRE RESCUE, LAWENFORCEMENT, GENERAL GOVERNMENT, AND SOLID WASTE IMPACT FEES; PROVIDING FOR CONFLICTS; PROVIDING FOR SEVERABILITY; PROVIDING FOR CODIFICATION; AND PROVIDING AN EFFECTIVE DATE.

In accordance with the Code of the City of North Port, Florida, Chapter 58 - Planning and Development, Article III. - Impact Fees and Florida Statutes Section 163.31801, the City of North Port hereby provides 90-days' notice of imposing new or increased impact fees to fund City Park, fire rescue, law enforcement, general government, and solid waste improvements necessitated by growth and development.

The impact fees shall be imposed upon all new construction, both residential and nonresidential, occurring within the boundaries of the City. The City shall collect the fees at or prior to issuance of a certificate of occupancy for new construction at the rates to be decided and adopted at the June 21, 2022, City Commission meeting.

The proposed ordinance may be inspected by the public at City Hall during the hours of 8:00 a.m. and 5:00 p.m., Monday through Friday. Copies of the City Code Chapter 58 - Planning and Development, Article III. - Impact Fees, are available at the City Clerk's Office or on the City Clerk's webpage at http://www.cityofnorthport.com. All interested parties may attend the meeting and be heard with respect to the proposed ordinance.
