

# **PROJECT APPROACH**

The first step of this process will be to receive a notice to proceed from the City of North Port. The next step is our design build team, led by Vice President, Ross Russo, will begin the process with a kick off meeting with the City of North Port. At this meeting, our design build team will meet with the City stakeholders to review the existing concepts provided for the Myakkahatchee Disc Golf Course and refine the scope of work. All members of our team will be present to ensure nothing is missed. Once we have direction on the refined scope of work, our team will prepare 30% design and present to the City. Once everyone understands the where the design stands, any feedback can be taken into account at this time.

The next step of the process is our team will take all feedback from the 30% design meeting and incorporate that feedback into the 60% design documents. We will then meet with the City to review these drawings and scope of work. Our team will then take these final pieces of feedback and integrate it into the 90% design documents. We will have a final meeting with the City to get all stakeholders in agreement with the design documents and scope of work. Our team will then proceed with finalized 100% drawings.

During the design process, we would be simultaneously proceeding with the permitting phase starting with a Southwest Florida Water Management District (SWFWMD) pre-application meeting and a Development Review Committee (DRC) pre-application meeting. At 60% design documents, we would submit these plans to the DRC for their first review, as well as to the Florida Department of Environmental Protection (FDEP) for their review. Any feedback from these agencies will be provided and integrated into the 90% design documents and resubmitted for their final review and approval. At 90% design drawings we will submit them to the City of North Port Building Department.
