


Following is the May 2022 monthly report for the Parks & Recreation Department, including an overview of the budget, attendance data, operational highlights, and updates on various initiatives.

Warm Mineral Springs Park Admission







May Events/Programs/Accomplishments

Administration

- Conducted monthly CAPRA review.
- To date this fiscal year, the estimated value of in-kind donations received is \$22,678. Total financial sponsorship received to date this fiscal year is \$16,150, an increase of 144% to date this fiscal year in comparison to the previous time period.
- Staff secured additional sponsorship commitments to the upcoming Freedom Festival event.
- The Parks & Recreation Facebook page now has 11,029 followers. In the month of May, the page garnered an organic post reach of 242,487, had 15,996 post engagements, as well as 32,803 video views (an increase of 264% in comparison to the previous time period). Active Facebook events had a reach of 62,053 with 1,422 engagements.
- Visitors to Warm Mineral Springs Park for the month of May totaled 15,274, bringing total park attendance up 16.15% the first 8 months of FY22, in comparison to the same time period of prior fiscal

years. Wam Mineral Springs Park closed 5/16 and 5/18 due to facilities issues, and also closed on 5/23 and 5/26 due to wildlife in the water. Visitation was in part driven by the 'Experience Vintage Florida' Google Search Engine Marketing (SEM) campaign, which targets individuals throughout the State of Florida. In May, the SEM ads generated 21,413 impressions, 2,001 clicks, 260 calls to the park, and 1,104 local actions (which indicate intent to visit). Fiscal year to date, the campaign cost \$2,458.41.

- To date this fiscal year, staff have completed 152 marketing requests submitted through the Department tracker for projects ranging in size from small to large. In addition, the Marketing and Engagement Coordinator fielded 7 requests from the media for a total of 39 completed media requests to date this fiscal year.
- Staff completed 9 hours of general public engagement in May, for a total of 86 hours year to date.

Recreation Division

- On May 6, the Recreation Division hosted the Concert in the Park at the City Center Front Green with approximately 400 attendees enjoying music, food and beverages in partnership with the North Port Rotary Club. Staff also held Kids Night Out on May 6 with 26 enrollees.
- Newcomer Day was held at the George Mullen Activity Center on May 14 in partnership with the North Port Area Chamber of Commerce. 150 attendees had the chance to interact with 22 nonprofit organizations and 17 businesses.
- On May 14, the Division hosted the inaugural North Port's Got Talent at the North Port Performing Arts Center. A total of 560 attendees purchased tickets to the production where they were able to enjoy 27 acts of various ages and abilities.
- 37 teens attended Teen Talk at the Morgan Family Community Center on May 19.
- The Reservations Team processed 206 reservations and received seven new Special Event Applications in the month of May.

Aquatics Division

- The Division welcomed Jesse Hill as the new Aquatics Program Coordinator.
- In recognition of National Drowning Prevention Awareness month, staff completed 15 hours of specific water safety public engagement, in addition to a robust social media campaign.
- The Monda Kids SWIM and Sarasota County Schools partnership program for free second grade swim lessons concluded. In total, 605 children participated and saw some improvement in their swimming abilities and learned how to continue lessons, or apply for the Youth Scholarship Program.
- Staff hosted a Lifeguard pre-hiring event on site which included skills assessment, hiring documentation, as well as screening process assistance.
- A third Lifeguard class was completed for staff to receive their American Red Cross Professional Rescuer, First Aid, and CPR certification. In addition, staff certified 10 Summer Camp Counselors in First Aid and CPR.
- The Division instructed over 90 participants in Learn to Swim classes, swim lessons and Float 4 Life classes.
- A full Water Safety Instructors Class (WSI) was held with four new learn to swim instructors certified through the American Red Cross. 1 public patron was re-certified.
- Despite attendance being impacted by inclement weather, residents who braved the rain enjoyed the Splash into Summer and the Mayday Drowning Prevention Expo which offered residents complimentary admission to the facility on May 7.
- NPAC received an award for ranking over 90% on the annual facility management and unannounced lifeguard audit program.

- The Division set an attendance record on Sunday, May 29 welcoming 1,209 visitors to the facility.
- Summer operating hours for NPAC started on May 28. The facility will be open daily starting at 10:00 a.m. and will close at 5:00 p.m. Sunday Thursday, and 7:00 p.m. on Friday Saturday.

Park Maintenance Division

- The Division removed graffiti from playground equipment at multiple park locations.
- Staff installed a new chain and signage at Dallas White Park in coordination with the perimeter fencing project.
- Installed a new dog waste dispenser at the City Center Front Green.
- Installed new playground mulch at several park sites.
- Pruned oak trees at the Garden of the Five Senses and replaced two fence posts at McKibben Park.
- Installed a new combination lock to the campsite gate at Myakkahatchee Creek Environmental Park.
- Prepared Narramore Park softball field number 2 for a High School game.
- Completed field improvements at Narramore Softball fields including removal and raising of infield lips, edged and installed new homeplate.
- Completed aerating of the Narramore Park soccer fields.

The Recreation Division hosted the inaugural North Port's Got Talent show on May 14.



605 second graders total participated in the MONDA Kids Swim program.
