### RESOLUTION NO. 2022-R-31

A RESOLUTION OF THE CITY COMMISSION OF THE CITY OF NORTH PORT, FLORIDA, AMENDING THE NON-DISTRICT BUDGET AND CAPITAL IMPROVEMENT BUDGET FOR FISCAL YEAR 2021-2022 FOR MYAKKAHATCHEE CREEK GREENWAY TRAIL PROJECT P10MCG IN THE AMOUNT OF \$319,400, ~~AND \$1,750 FOR THE FIRST FLOOR LOBBY MURAL IN THE AMOUNT OF \$1,750~~; PROVIDING FOR FINDINGS; PROVIDING FOR CONFLICTS; PROVIDING FOR SEVERABILITY; AND PROVIDING AN EFFECTIVE DATE.

**WHEREAS**, Resolution No. 2021-R-43 approved the Non-District Budget and Capital Improvement Budget for fiscal year 2021-2022; and

**WHEREAS**, Florida Statutes Section 166.241(7)(c) requires that a budget amendment be adopted in the same manner as the original budget; and

**WHEREAS**, Resolution No. 2021-R-43 established procedures for resolutions amending the Non-District Budget or Capital Improvement Budget for Fiscal Year 2021-2022, and required that each must be heard twice and must be noticed once in a newspaper of general circulation in the municipality; and

**WHEREAS**, the City Commission desires to amend the Non-District Budget and Capital Improvement Budget for supplemental appropriations.

5.01 If a court of competent jurisdiction finds that any section, subsection, sentence, clause, phrase, or provision of this resolution is for any reason invalid or unconstitutional, that provision will be deemed a separate, distinct, and independent provision and will not affect the validity of the remaining portions of the resolution.

**SECTION 6 – EFFECTIVE DATE**

6.01 This resolution takes effect immediately.
