NARRATIVE

On 04/17/2024 at 1738 hours, I was dispatched to 6205 W Price Blvd in North Port Florida (North Port Aquatic Center) for a crash with property damage.

Upon my arrival, I spoke with the complainant, Aquatic manager Devon Poulos, who advised a red jeep displaying FL registration 16AZMC crashed into an above ground pipe causing it to bust causing approximately \$5000 in damage.
