The permanent work is at the waste water plant – **5355 Pan American Blvd.** {will need someone to let you in gate}

This scope of work is too build a permanent structure over the centrifuge.

In a separate bid for buttoning up – the scope of work can be to tarp the sheds, waterproofing conex container, temporary guardrails and handrails – temporary structure over digester transfer station & pump area. (Also on that – if you want to bid the permanent work part of that handrails and guardrails and structures)

**1850 West Price** - the old OPS building needs to be buttoned up to keep employees out and roof tarped at minimum.

**6644 West Price** – the same for this building – buttoned up to keep employees out and roof tarped at minimum

**Sam Shapos Way** – the Al Gol Building and the modular buttoned up to keep public out, roof tarped at minimum

I so apologize, I have been trying to get caught up and the scope of work has changed after several meetings and there are a list of some of the facilities that we will be demolish once the insurance and FEMA is over.

Did you want to rebid the locations to be sure they are buttoned up for life and safety concerns.

1850 W Price Blvd.

I have reviewed your other locations and if you feel that the work described would be sufficient for life and safety of the buildings they can stand as is, I did not notice anything for the shop located behind the Utilities Admin building at 6644 W Price warehouse., so if that was overlooked in the initial visit please adjust.

Also, do you bid permanent work – the centrifuge located at 5355 Pan American needs a permanent structure built over it – we cannot (by warranty) do temporary at that location. It will require 3 bids and issued PO, but you are set up as a vendor.

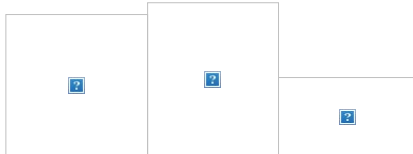
