## ORDINANCE NO. 2022-29

1 AN ORDINANCE OF THE CITY OF NORTH PORT, FLORIDA, REPEALING CHAPTER 4,  
2 ARTICLE VIII OF THE CODE OF THE CITY OF NORTH PORT, FLORIDA AND THEREBY  
3 DISBANDING THE PUBLIC UTILITY ADVISORY BOARD; PROVIDING FOR FINDINGS;  
4 PROVIDING FOR CONFLICTS; PROVIDING FOR SEVERABILITY; PROVIDING FOR  
5 CODIFICATION; AND PROVIDING AN EFFECTIVE DATE.

7 **WHEREAS**, the City Commission has considered the membership, the quorum requirements, and the  
8 attendance for the Public Utility Advisory Board; and  
9

10 **WHEREAS**, the City Commission finds that these amendments serve the public health, safety, and welfare  
11 of the citizens of the City of North Port, Florida.  
12

13 **NOW, THEREFORE, BE IT ORDAINED BY THE CITY COMMISSION OF THE CITY OF NORTH PORT, FLORIDA:**

15 **SECTION 1 – FINDINGS**

16  
17 1.01 The above recitals are true and correct and are incorporated in this ordinance by reference.

19 **SECTION 2 – REPEAL**

20  
21 2.01 Chapter 4, Article VIII, entitled “Public Utility Advisory Board” of the Code of the City of North  
22 Port, Florida is hereby repealed in its entirety.  
23

24 **SECTION 3 – CONFLICTS**

25  
26 3.01 In the event of any conflict between the provisions of this ordinance and any other ordinance, in  
27 whole or in part, the provisions of this ordinance will prevail to the extent of the conflict.  
28

29 **SECTION 4 – SEVERABILITY**

30  
31 4.01 If a court of competent jurisdiction finds that any section, subsection, sentence, clause, phrase,  
32 or provision of this ordinance is for any reason invalid or unconstitutional, that provision will be  
33 deemed a separate, distinct, and independent provision and will not affect the validity of the  
34 remaining portions of the ordinance.

36 **SECTION 5 – CODIFICATION**

37  
38 5.01 In this ordinance, additions are shown as underlined and deletions as ~~striketrough~~. Any  
39 additional codification information and notations appear in *italics*. These editorial notations are  
40 not intended to appear in the codified text.

42 **SECTION 6 – EFFECTIVE DATE**

43  
44 6.01 This ordinance takes effect immediately upon adoption.
