ORDER FOR COMPLIANCE NOTICE OF HEARING TO ASSESS ADMINISTRATIVE FINE

AFTER DUE NOTICE to Respondent(s), the HEARING OFFICER OF THE CITY OF NORTH PORT heard testimony and took evidence concerning the above-styled cause at a public hearing on September 28, 2023. Based upon the testimony heard and the evidence presented, the HEARING OFFICER established the following FINDINGS OF FACT in this cause:

- 1. Respondent(s), Dieupromaitre Hyppolite & Marceline Corrielant, own(s) the property commonly known as, 3451 S Chamberlain Blvd North Port, Sarasota County, Florida (LOT 17 BLK 130 8TH ADD TO PORT CHARLOTTE, a subdivision according to Plat thereof, of the Public Records of Sarasota County, Florida).
- 2. Code Enforcement Inspector DAVE GRANDT served the Respondent(s) a NOTICE OF VIOLATION, dated May 10, 2023.
- 3. The Respondent did not comply with the NOTICE OF VIOLATION within the time frame set forth therein.


