

**FIRST AMENDMENT TO AGREEMENT BETWEEN
THE CITY OF NORTH PORT AND ADVANCED DATA PROCESSING, INC.
FOR PUBLIC EMERGENCY MEDICAL TRANSPORT FEE CHANGE**

THIS FIRST AMENDMENT (the "First Amendment") is made and entered into this 2nd day of July 2020 (the "Amendment Effective Date") by and between City of North Port, a municipal corporation of the State of Florida ("City") and Advanced Data Processing, Inc. (ADPI), a subsidiary of R1 RCM Inc., a Delaware corporation ("Contractor").

WHEREAS, City of North Port Commission voted in September 2017 to utilize the Agreement for Medical Billing Services between The City of Tamarac, Florida and ADPI effective October 1, 2016 (the "Agreement");

WHEREAS, the piggybacked Agreement between The City of Tamarac, Florida and ADPI was amended in June 2019 to reflect a new Public Emergency Medical Transport (PEMT) fee;

WHEREAS, the parties desire to change the PEMT fee offered to the City of North Port.

NOW THEREFORE, in consideration of the foregoing, the mutual promises and covenants hereinafter set forth, and other good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, the parties agree as follows:

1. The PEMT fee as modified in the City of Tamarac shall also apply to the City of North Port, as follows:

The contingency fees to be paid associated with the respective successful implementation and generation of incremental Medicaid revenues as a result of the Certified Public Expenditure (CPE) for Emergency Medical Services Supplemental Payment Programs are twelve percent (12%) of City revenues.


2. Capitalized terms not otherwise defined in this Supplement shall have the meanings ascribed to such terms in the Agreement. All terms and conditions of the Agreement are hereby ratified and shall remain in full force and effect except to the extent this Supplement expressly modifies or is inconsistent with the terms and conditions of the Agreement, in which case the terms of this Supplement shall be controlling.
