### CALL TO ORDER

Mayor Stokes called the meeting to order at 9:00 a.m.

### 2. GENERAL BUSINESS:

- A. [24-0530](#) Discussion and Possible Direction Regarding the Draft Facility Lease Policy for City-Owned Facilities.

Mayor Stokes announced the item.

Commissioner Petrow arrived at 9:02 a.m.

Mr. Fletcher introduced the item.

Ms. Wisner provided a presentation including facility lease policy scope, current leases,

policy goals, lease comparison, consideration for use of property, responsibilities, market value determination, discounted leases, discounted leases responsibilities, and facility lease policy.

Commission questions and discussion took place regarding lease comparisons, market values, current lease effective dates, air and ambulance leases, building evaluation criteria, impact on current leases, community impact considerations, North Port Squared lease relief options, current and proposed lease amounts, annual tenant reports, establishing set rates, frequency of market rate determination, revenue allocations, building maintenance, clauses, differential impact, vacancy advertisements, number of properties, process for selection of tenants, delegations to City Manager, affordability, and routine staff approvals.

Ms. Wisner reviewed next steps.

There was no public comment.

**B. [24-1653](#)** Discussion and Possible Direction Regarding the Debt Management Advisory Committee Ordinance No. 2024-37 and Commission Policy 2024-01.

Mayor Stokes announced the item.

Mr. Fletcher introduced the item.

Commission questions and discussion took place regarding timeline of referendum question, committee responsibilities, and whether to suspend the board or fill positions.

There was no public comment.

**C. [24-1635](#)** Discussion and Possible Direction Regarding the City's Inclusion of Referendum Questions on the Town of Longboat Key's March 11, 2025, Municipal Election.

Mayor Stokes announced the item.

Mr. Fletcher introduced the item.

Commission questions and discussion took place regarding Federal Emergency Management Agency (FEMA) reimbursement, number of referendum questions, pros and cons of referendum, timing for educating the public, declared emergency borrowing, police headquarters, selecting infrastructure projects, additional questions including City Attorney and City Clerk residency requirements and commissioner compensation, and timing of referendum.

Mr. Fletcher provided clarification regarding effective date of compensation changes.

Commission questions and discussion continued regarding emergency disaster relief coverage, 5-year Capital Improvement Plan, concern with upcoming hurricane seasons, need for more information, public input, and inclusion of imminent infrastructure needs.

***There was consensus to add a referendum question to the Town of Longboat Key's March 11, 2025 Election to request the ability of the City of North Port to borrow***

*money in situations of federal, state, or local declared emergencies.*

Mr. Fletcher spoke to timelines and follow-up discussion.

Commission questions and discussion continued regarding commission compensation and charter officer residency requirements.

There was no public comment.

Discussion and Possible Direction Regarding Next Steps for Florida Department of Transportation Related to the Yorkshire / Raintree Interchange

Commission questions and discussion took place regarding local municipality interest, infrastructure projects, discussion with Charlotte County, and parallel road plans.

Ms. Ray spoke to activity center master plans and expanding urban compound.

Mr. Speake spoke to status of interchange, improvements to Raintree and Yorkshire, meeting with Charlotte County, and future updates.
