NOTICE OF CONTINUANCE

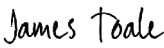

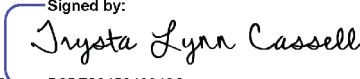

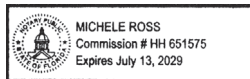
