RESOLUTION NO. 2021-R-02

A RESOLUTION OF THE CITY OF NORTH PORT, FLORIDA, ADOPTING CITY COMMISSION POLICY NO. 2021-01 RELATED TO TRAVEL EXPENSES FOR CITY COMMISSIONERS; PROVIDING FOR CONFLICTS; PROVIDING FOR SEVERABILITY; AND PROVIDING AN EFFECTIVE DATE.

WHEREAS, Section 2-24(a) of the Code of the City of North Port, Florida (“City Code”) addresses the reimbursement of travel expenses incurred by City Commissioners; and

WHEREAS, this new policy supersedes and takes the place of the codified language in City Code Section 2-24, which shall be repealed separately by Ordinance No. 2020-43; and

WHEREAS, it is the City’s intent to establish a policy related to expenses incurred by City Commissioners when traveling for City business; and

WHEREAS, the implementation of a policy will ensure consistency in the process of travel reimbursement for City Commissioners; and

WHEREAS, the City Commission finds that this policy serves the public health, safety, and welfare of the citizens of the City of North Port, Florida.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COMMISSION OF THE CITY OF NORTH PORT, FLORIDA:

SECTION 1 – INCORPORATION OF RECITALS

1.01 The recitals outlined above are incorporated by reference as findings of fact as if expressly set forth herein.

SECTION 2 – RESOLUTION

2.01 The City Commission hereby adopts Policy No. 2021-01 “City Commission Travel Policy,” which is attached and incorporated as if set forth in this resolution, as an administrative policy of the City Commission of the City of North Port, Florida.

SECTION 3 – CONFLICTS

3.01 In the event of any conflict between the provisions of this resolution and any other resolution or portions thereof, the provisions of this resolution shall prevail to the extent of such conflict.

SECTION 4 – SEVERABILITY

4.01 If any section, subsection, sentence, clause, phase, or provision of this resolution is for any reason held invalid or unconstitutional by any court of competent jurisdiction, such provision shall be deemed a separate, distinct, and independent provision and such holding shall not affect the validity of the remaining portions hereof.

SECTION 5 – EFFECTIVE DATE

5.01 This resolution shall take effect immediately upon adoption by the City Commission of the City of North Port, Florida.
