



# City of North Port

## ORDINANCE NO. 2024-22

1           **AN ORDINANCE OF THE CITY OF NORTH PORT, FLORIDA, RELATING TO SOLID WASTE;**  
 2           **AMENDING THE CODE OF THE CITY OF NORTH PORT, FLORIDA, CHAPTER 62, SOLID**  
 3           **WASTE, ARTICLE III. - COLLECTION AND DISPOSAL, TO CLARIFY DEFINITIONS AND**  
 4           **UPDATE REFERENCES; PROVIDING FOR FINDINGS; PROVIDING FOR CONFLICTS;**  
 5           **PROVIDING FOR SEVERABILITY; PROVIDING FOR CODIFICATION; AND PROVIDING AN**  
 6           **EFFECTIVE DATE.**

7  
 8           **WHEREAS**, on August 6, 2024, the City Commission adopted Ordinance No. 2024-13, providing for the  
 9           repeal of Unified Land Development Code, Chapters 1, 5, 9, 13, 14, 17, 18, 21, 25, 28, 33, 37, 41, 45, 49,  
 10          53, 55, 57, 58, 59, 60, and 61, and replacement of those chapters with Chapters 1 through 4 and 6, and  
 11          Appendices; and

 13          **WHEREAS**, references in Chapter 62 of the Code of the City of North Port, Florida (“City Code”) are no  
 14          longer accurate, as the Unified Land Development Code (“ULDC”) allows multi-purpose buildings in  
 15          several different zoning districts and does not define “home business”; and

16  
 17          **WHEREAS**, these amendments are required to achieve harmony between the City Code and the ULDC;  
 18          and

19  
 20          **WHEREAS**, the City Commission finds that these amendments serve the public health, safety, and welfare  
 21          of the citizens of the City of North Port, Florida.

22  
 23          **NOW, THEREFORE, BE IT ORDAINED BY THE CITY COMMISSION OF THE CITY OF NORTH PORT, FLORIDA:**

 25          **SECTION 1 – FINDINGS**

 27          1.01       The above recitals are true and correct and are incorporated in this ordinance by reference.  
 28  
 29          1.02       In accordance with Florida Statutes Section 166.041(4)(a), the City timely posted a business  
 30          impact estimate on the City’s website on or before the date the newspaper published notice of  
 31          this ordinance’s final reading.  
 32

33          **SECTION 2 – ADOPTION**

 35          2.01       Chapter 62 of the Code of the City of North Port, Florida is hereby amended as follows:  
 36

37 **“Chapter 62 – SOLID WASTE**

38 . . .

39 **ARTICLE III. – COLLECTION AND DISPOSAL**

40 . . .

41 **Sec. 62-44. – Definitions and word usage.**

42 . . .

43 *Commercial - multipurpose buildings.* When a building is ~~zoned commercial and is~~ devoted to mixed  
44 commercial and residential space, the solid waste collection rates are based on commercial rates for any or  
45 all units. The owner shall supply service to the commercial lessee or residential lessee in accordance with  
46 district ordinances.

47 . . .

48 *Home business.* Any business based at a residence which generates more solid waste than can be  
49 contained in the 95-gallon container provided for residential use ~~exclusive of definitions in zoning~~  
50 ~~regulations section 53 of the North Port Land Development Code.~~

51 . . .

52 **Sec. 62-48 Collection containers.**

53 . . .

54 (h) *Service initiation fee for automated garbage container.* ~~Effective September 1, 2004, all~~ All newly  
55 constructed single and multifamily residential structures utilizing an automated garbage container  
56 shall be required to pay a service initiation fee. Such fee shall be collected ~~by the building department~~  
57 ~~at such time that a certificate of occupancy is issued~~ prior to the city’s delivery of containers. All  
58 containers shall remain the property of the city and shall remain at the location assigned by the solid  
59 waste ~~division~~ district.

60 . . .”

62 **SECTION 3 – CONFLICTS**

63

64 3.01 In the event of any conflict between the provisions of this ordinance and any other ordinance, in  
65 whole or in part, the provisions of this ordinance will prevail to the extent of the conflict.

67 **SECTION 4 – SEVERABILITY**

68

69 4.01 If a court of competent jurisdiction finds that any section, subsection, sentence, clause, phrase,  
70 or provision of this ordinance is for any reason invalid or unconstitutional, that provision will be  
71 deemed a separate, distinct, and independent provision and will not affect the validity of the  
72 remaining portions of the ordinance.

74 **SECTION 5 – CODIFICATION**

75

76 5.01 In this ordinance, additions are shown as underlined and deletions as ~~strikethrough~~. Any  
77 additional codification information and notations appear in *italics*. These editorial notations are  
78 not intended to appear in the codified text.

80 **SECTION 6 – EFFECTIVE DATE**

81

82 6.01 This ordinance takes effect on October 28, 2024.
