Five (5) responses were received for RFP 2025-01. One firm, Looks Great Services of MS, Inc., was found non-responsive for not turning in a required document. The Selection Committee held telephone discussions and evaluations on April 4, 2025. During the evaluation one of the vendors, TFR Enterprises, was found non-responsive/non-responsible for turning in cost-plus pricing in on their price schedule which would not be reimbursable through FEMA.
