#### Commissioner McDowell:

Good afternoon. Pursuant to your request, the following provides responses to your supplemental questions regarding the placement of a Federal Emergency Management Agency (FEMA) trailer on the Rapkin's property located at 4696 Libby Road:

1. **Question**: As follow-up questions,, is there a reason the FEMA modular home were excluded from the ER Ordinance enacted?

**Response**: Emergency Order No. 2022-09, ratified by the City Commission on October 25, 2022, suspended the Code of the City of North Port, Florida, Sec. 59-16 (h) 30-day limitation on occupying, camping, or living in vehicles parked on residential lots. The term "vehicle" includes motorized recreational vehicles (RVs) and travel trailers (camper trailers and fifth-wheel). Modular and Manufactured homes are not "vehicles" and are not mentioned nor authorized in Code of the City of North Port, Florida, Sec. 59-16 (h).

2. **Question**: could you please explain the difference between a FEMA trailer and a FEMA Modular home? It seems myself and many others use these terms interchangeably.

**Response**: The terms "trailer," "modular" home, and "manufactured" home describe distinctly different things, as described below.

#### Trailer

A FEMA "trailer" is also referred to as a "travel trailer" and is meant to be pulled by another vehicle (see Photo 1, below). This is the most common type of post-storm housing provided by FEMA. It is easily moved, fits in a standard driveway, has a self-contained sanitation system that is emptied periodically, can be plugged into existing electrical outlets and/or a temporary pole, and can get its water source from a standard water hose.

# **Modular Home**

FEMA does not install "modular" homes (see Photo 2, below). Modular homes are built in sections offsite and then transported to the building site where they are assembled on a permanent foundation. Modular homes must meet the provisions of the Florida Building Code.

## Manufactured Home

FEMA does occasionally install "manufactured" homes (see Photo 3, below), though many jurisdictions do not allow these. This term is often used interchangeably with "mobile" homes, however, the distinction is that "manufactured" homes are those dwelling units build after 1976 and must be in compliance with Housing and Urban Development (HUD) guidelines. They are not regulated by the Florida Building Code and City inspectors cannot inspect them for compliance with such. They are also not allowed to be installed in Special Flood Hazard Areas (flood zones). Most FEMA Manufactured homes are approximately 1,000 square feet, are semi-permanent structures, and do not fit in a standard driveway. Typically land must be cleared and leveled prior to placement. A Manufactured home would need to be connected to City water/sewer or to well/septic.

1. Question: Is there a reason FEMA trailers are not allowed on private property in emergency situations? Could I please have the code number that is preventing the FEMA trailers to be used for housing while our residents rebuild after the hurricane? Please consider this email as meeting my deadline requirements for including agenda items for April 25th Commission Meeting. As soon as I receive a response to my questions, I will submit the legislative summary text.

**Response:** There is already a FEMA trailer located on private property at 4696 Libby Road. The Rapkin's requested it be replaced with a mobile (manufactured) home rather than a travel trailer. Mobile (manufactured) homes are not authorized under the Emergency Order. Please also note that Alaina Ray, Neighborhood Development Services (NDS) Director has been communicating with Mr. Rapkin regarding this issue. However, Mr. Rapkin has informed Director Ray on multiple occasions that they have no intention of repairing their home and plan to eventually abandon the property. No permit applications for repairs have been submitted to the NDS Department and the Rapkin's have not had contractors assess their damage.
