Requires changes to Procurement Code, Procurement Manual, forms, and SOP's. Implementation would need to address potential conflicts with local preference.</p> <p>This option would be relatively easy to implement and is the least likely to delay the procurement process.</p> <ul style="list-style-type: none"> - Require bidders and proposers to submit documentation with bids and proposals to verify they are an American company - Apply preference to bids as either a price-match or by agreeing to pay more (up to x percent above low non-American company) - Apply to proposals as an allocation of points for American companies - Identify waivers from preference for certain types of procurements (CCNA, waivers, single sources, sole sources, piggybacks, grant funded projects, etc.)
