## **ORDINANCE NO. 2023-12**

AN ORDINANCE OF THE CITY OF NORTH PORT, FLORIDA, AMENDING THE UNIFIED LAND DEVELOPMENT CODE, CHAPTER 53, ARTICLE XVIII. – V VILLAGE, SECTION 53-213.B; ADOPTING AND INCORPORATING THE TOLEDO VILLAGE VILLAGE DISTRICT PATTERN BOOK FOR A ±2,086 ACRE AREA GENERALLY LOCATED EAST OF TOLEDO BLADE BOULEVARD AND NORTH OF INTERSTATE 75; PROVIDING FOR FINDINGS; PROVIDING FOR CONFLICTS; PROVIDING FOR SEVERABILITY; PROVIDING FOR CODIFICATION; AND PROVIDING AN EFFECTIVE DATE.

WHEREAS, the City of North Port plans and manages the future growth and development of the City by 1 2 adhering to the City of North Port Comprehensive Plan and Unified Land Development Code (ULDC); and 3 4 WHEREAS, Chapter 53, Article XVIII of the (ULDC), Section 53-213.B regulates the Village District Pattern Book 5 for the village development; and 6 7 WHEREAS, Applicant Forestar ("Applicant"), represented by Tony Squitieri, filed Petition No. VP2-22-140, 8 requested approval of the Toledo Village District Pattern Book for 2086± acres of land; and 9 10 WHEREAS, the Project consists of 11 parcels, generally located east of Toledo Blade Boulevard, a portion 11 being approximately one (1) mile north of the I-75 interchange; and 12 13 WHEREAS, the Planning and Zoning Advisory Board, designated as the local planning agency, held a properly 14 noticed public hearing on , 2023 to receive public comment on the subject matter of this 15 ordinance and to make its recommendation to the City Commission; and 16 17 WHEREAS, the City Commission of the City of North Port held properly noticed public hearings at the first and second reading of this ordinance, reviewed the recommendations of the Planning and Zoning Advisory 18 19 Board, and received public comment; and 20 21 WHEREAS, the City Commission finds that the ordinance serves the public health, safety, and welfare of 22 the citizens of the City of North Port, Florida. 23 24 NOW, THEREFORE, BE IT ORDAINED BY THE CITY COMMISSION OF THE CITY OF NORTH PORT, FLORIDA: 25 26 **SECTION 1 – FINDINGS** 27
