A Resolution of the City Commission of the City of North Port, Florida, as the Governing Body of the North Port Road and Drainage District, Adopting a Non-Ad Valorem Assessment Methodology; Adopting, Certifying, and Confirming the Non-Ad Valorem Assessment Rates and Capital Improvements Assessment Rates and Adopting and Certifying the Non-Ad Valorem Assessment Roll for the North Port Road and Drainage District for Fiscal 2023-2024; Providing for Findings; Providing for Conflicts; Providing for Severability; and Providing an Effective Date.

A motion was made by Commissioner McDowell to instruct the City Manager to include the Road and Drainage Fund Balance Plan at the Road and Drainage District meeting being held September 21, 2023. The motion failed due to lack of a second.
