- (a) The parks and recreation advisory board shall advise the city commission on parks and recreation matters.
- (b) The advisory board shall make written and verbal recommendations to the city commission regarding parks and recreation matters within the City of North Port, to include, but not limited to:
- (1) Use and condition of all public recreation facilities and recommend such changes as the advisory board shall deem appropriate;
 - (2) Recommend recreational programs to ensure that all public recreational facilities are properly and efficiently operated and each facility is utilized to its optimum to the benefit of all citizens;
 - (3) Explore various sources of grant funds that may be available for recreational programs and/or facilities and assist in development of an application for such funds; and
 - (4) Recommend a representative from the board to serve as a representative on the Sarasota County Parks Advisory and Recreation Council to the city commission.

Membership Requirements

The parks and recreation advisory board shall consist of seven regular members, two alternate members, and two youth members. Members shall include representatives of the community at large and the business community, with at least one representative from each sector. Youth board members shall serve a one-year term, and may be reappointed for an additional one-year term if they are still in high school and under 18 at the time of reappointment. Youth who have aged out may apply for membership as an adult member.
