#### **ORDINANCE NO. 2025-30**

AN ORDINANCE OF THE CITY OF NORTH PORT, FLORIDA, AMENDING THE CODE OF THE CITY OF NORTH PORT, FLORIDA, APPENDIX A – CITY FEE SCHEDULE; AMENDING CITY-WIDE FEES; UTILITIES FEES; PROVIDING FOR FINDINGS; PROVIDING FOR CONFLICTS; PROVIDING FOR SEVERABILITY; PROVIDING FOR CODIFICATION; AND PROVIDING AN EFFECTIVE DATE.

**WHEREAS**, the City Commission of the City of North Port, Florida has the duty, right, power, and authority to levy and collect fees for municipal purposes, including user fees as set forth in Florida Statutes Section 166.201; and

WHEREAS, the City's fees provide funding for municipal purposes, including but not limited to, conducting municipal government, performing municipal functions, and rendering municipal services; and

WHEREAS, the City Fee Schedule is codified as Appendix A to the Code of the City of North Port, Florida; and

**WHEREAS**, GovRates Inc. performed a formal analysis in fiscal year 2025 of the City's water and wastewater utility rates, fees, and charges, which showed a need to update the miscellaneous fees in order to recover the cost of providing services to utility customers; and

WHEREAS, the City Commission desires to update the City Fee Schedule; and

**WHEREAS,** the City Commission finds that these amendments serve the public health, safety, and welfare of the citizens of the City of North Port, Florida.

NOW, THEREFORE, BE IT ORDAINED BY THE CITY COMMISSION OF THE CITY OF NORTH PORT, FLORIDA:

#### **SECTION 1 – FINDINGS**

1.01 The above recitals are true and correct and are incorporated in this ordinance by reference.

- 1.02 In accordance with Florida Statutes Section 166.041(4)(a), the City timely posted a business impact estimate on the City's website on or before the date the newspaper published notice of this ordinance's final reading.
- 1.03 The City Commission finds that the fees established in this ordinance are fair, reasonable, just, and equitable.
- 1.04 The City Commission finds that the user fees established in this ordinance are imposed in the exercise of a proprietary activity and benefit the party paying the fee in a manner not shared by the general public.

#### **SECTION 2 – COMPREHENSIVE UTILITY RATE ANALYSIS**

- 2.01 GovRates, Inc. prepared the *Utility Rate Analysis* during fiscal year 2025.
- 2.02 The City Commission approves, adopts, and incorporates herein by reference, the *Utility Rate*\*\*Analysis\*, attached hereto as "Exhibit A."

#### **SECTION 3 – ADOPTION**

3.01 Appendix A of the Code of the City of North Port, Florida is hereby amended as follows:

#### **SECTION 5 – SEVERABILITY**

5.01 If a court of competent jurisdiction finds that any section, subsection, sentence, clause, phrase, or provision of this ordinance is for any reason invalid or unconstitutional, that provision will be deemed a separate, distinct, and independent provision and will not affect the validity of the remaining portions of the ordinance.

#### **SECTION 6 – CODIFICATION**

6.01 In this ordinance, additions are shown as <u>underlined</u> and deletions as <u>strikethrough</u>. Any additional codification information and notations appear in *italics*. These editorial notations are not intended to appear in the codified text.

#### **SECTION 7 – EFFECTIVE DATE**

7.01 This ordinance takes effect November 1, 2025.

# **Subject:** Utility Rate Analysis – Miscellaneous Service Charges

The City of North Port (the "City") has several miscellaneous utility charges or fees that are billed to customers to recover costs for specific services provided by the utility at the request of a customer (e.g., service turn on) or by a direct action of the customer as it relates to City policy and procedures (e.g., customer disconnect for nonpayment). Revenues derived from these charges reduce the level of expenditures (revenue requirements) that must be recovered from monthly user rates. (The costs for the services are directly passed through to the customers requesting the services.) GovRates, Inc. ("GovRates") reviewed these charges as a component of our comprehensive utility rate analysis.

The GovRates recommendations with respect to the other / miscellaneous rates, fees, and charges of the utility are shown in the following Table ES-1. The proposed charges are based on the estimated costs of providing service, City policy, and charges for similar service that are currently imposed by other Florida utilities. Table ES-1 also contains an explanation or reason for each new or adjusted fee. A copy of our miscellaneous service charge evaluation model has been provided to the City staff for internal use.

We greatly appreciate the opportunity to be of service to the City and would like to thank the management and staff for their tremendous assistance and cooperation during the course of the utility rate analysis.
