

NORTH PORT ART ADVISORY RECOMMENDATIONS

CITY HALL AND POLICE STATION

- Per Ord. #2014-10, the North Port Art Advisory Board will be the curators of the exhibits unless it is specifically yielded to another entity
- Art will be changed on a scheduled, quarterly basis
- Unscheduled changes and/or requests to curate an exhibit will petition the Advisory Board
- City Hall Art Exhibits are required to fill all the art “stations” on the 1st and 2nd floor
- Police Station Exhibits are required to hang 2 pieces minimum, 4 maximum

Art Stations & Schedule

- City Hall: (must occupy ALL of Floor 1 & 2)
 - Floor 1 = 18 stations
 - Floor 2 = 18 stations
- North Port Police Station = 4 stations

QUARTER 1

- January (2nd Monday) – March (1st Monday)
- City Hall:
 - curator: North Port Visual Art Center
(must occupy ALL of Floor 1 & 2)
- North Port Police Station = 4 stations
 - curator: North Port Public Employees
(including Educators, Law Enforcement Personnel,
City Employees, etc.)

QUARTER 2

- March (2nd Monday) – May (1st Monday)
- City Hall
 - curator: North Port Art Advisory
 - School Students of North Port
(Art at the Hall reception, TBD annually in April)
- North Port Police Station
 - curator: North Port Visual Art Center

QUARTER 3

- May (2nd Monday) – Oct (1st Monday)
curator: North Port Art Center
 - City Hall – Local Artisans
 - Police Station – Local Artisans

QUARTER 4

- Oct (2nd Monday) – Jan (1st Monday)
curator: North Port City Hall Employees
 - City Hall – Holiday Décor (curator: NP City Hall Employees)
 - North Port Police Station (curator: NP Police Department)

North Port Public Art Theme Proposal

- The City of North Port Art Advisory Board recommends that the visual art theme for public art installations in The City of North Port should be Native Florida Flora and Fauna with concentration on the native flora and fauna of southwest Florida.
- Any and all participating artists shall be full or part-time Florida residents.

North Port Theme Proposal, continued

- In public, common areas, sculpture installations will be native Florida birds and in public parks and schools, Gopher Tortoises.
- Mural Installations on public buildings will be native fauna set in scenes of native flora or native Florida flora (genre variations will be encouraged).
- Provisions for exceptions to the theme might be made for site specific art installations (e.g.; North Port Skate Park, Braves Spring Training Facility, etc.). Such requests will go through a specific appeals process. Any exceptions will be few and far between as the City of North Port seeks to maintain a strong visual identity.

Suggested Projects Timeline

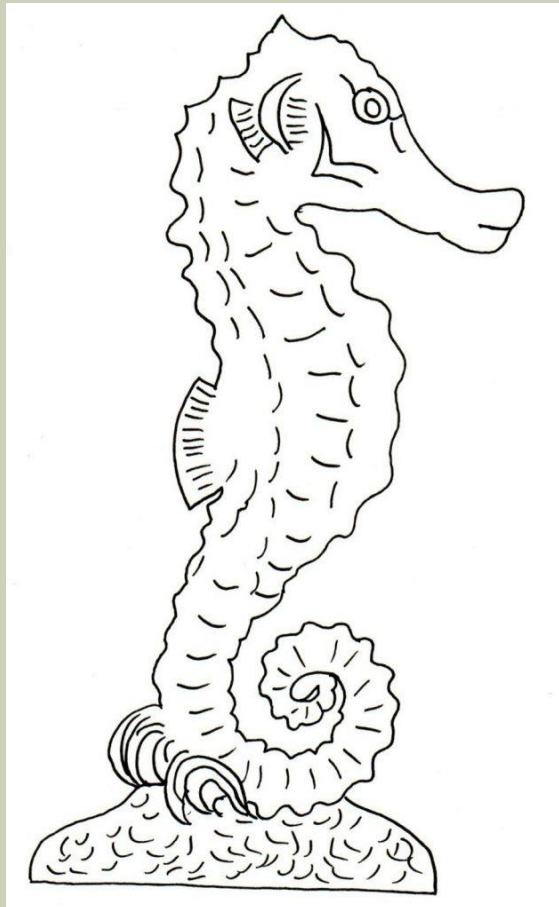
- 2019 - Sculpture at the Corner of Price & Sumter
