### ORDINANCE NO. 2018-16

**AN ORDINANCE OF THE CITY OF NORTH PORT, FLORIDA, RENAMING A SECTION OF SOUTH WEST VILLAGES PARKWAY TO "PLAYMORE ROAD," BEGINNING AT A POINT APPROXIMATELY 5,335 FEET SOUTH OF THE INTERSECTION OF U.S. 41 AND SOUTH WEST VILLAGES PARKWAY AND CONTINUING WESTWARD APPROXIMATELY 5,394 FEET TO ITS TERMINUS POINT; PROVIDING FOR FINDINGS; PROVIDING FOR RENAMING OF STREET; PROVIDING FOR CHANGE TO OFFICIAL CITY MAP; PROVIDING FOR CHANGE TO STREET SIGNS; PROVIDING FOR SEVERABILITY; PROVIDING FOR CONFLICTS; AND PROVIDING AN EFFECTIVE DATE.**

**WHEREAS**, on February 16, 2018, the City received an application for change of street name on behalf of the West Villages Improvement District to rename a section of South West Villages Parkway beginning at a point approximately 5,335 feet south of the intersection of U.S. 41 and South West Villages Parkway and continuing westward approximately 5,394 feet to its terminus point at Islandwalk Circle; and

**WHEREAS**, pursuant to the City of North Port Administrative Code Section 70-56(h)(6)b, the City's Planning and Zoning Division of the Neighborhood Development Services Department has reviewed the applicant's request for street renaming and has determined that it aligns with the future planned extension of the existing Playmore Road to the east of River Road and that it is consistent with the City of North Port and Sarasota County Long Range Transportation Plans; and

**WHEREAS**, the City's Planning and Zoning Division of the Neighborhood Services Department has determined that the change in street name meets the criteria required by Administrative Code Section 70-56(h)(6)f; and

**WHEREAS**, the City Commission finds that there are no affected properties requiring an address change; thereby rendering inapplicable the requirements of Administrative Code Section 70-58 to identify by resolution a master list of affected properties and to notify affected building and property owners; and

**WHEREAS**, the City Commission has held properly noticed public hearings on October 9, 2018, and October 23, 2018, and finds that the renaming of the above-cited portion of South West Villages Parkway to Playmore Road will maintain the health, safety, welfare and convenience of the citizens of the City of North Port, Florida, or the City itself, and voted to approve the renaming of the street; and

**WHEREAS**, as depicted on Exhibit "A," the above-cited portion of South West Villages Parkway will be renamed "Playmore Road"; and

**WHEREAS**, as depicted on Exhibit "B", the owner of the private western section of roadway within the Islandwalk Project Boundary has given express written consent for the change in street name.

**NOW, THEREFORE, BE IT ORDAINED BY THE CITY COMMISSION OF THE CITY OF NORTH PORT, FLORIDA, AS FOLLOWS:**

**SECTION 1. FINDINGS**

- 1.01 The recitals outlined above are incorporated by reference as findings of fact as if expressly set forth herein.
- 1.02 Exhibit "A" attached hereto is incorporated as if set forth fully herein.

**SECTION 2. RENAMING OF STREET**

- 2.01 The length of road beginning approximately 5,335 feet south of the intersection of U.S. 41 and South West Villages Parkway and ending at a point approximately 5,394 feet westward from the existing Playmore Road, as further depicted on Exhibit "A," is hereby changed from "South West Villages Parkway" to "Playmore Road."

**SECTION 3. CHANGE TO THE OFFICIAL CITY MAP**

- 3.01 Pursuant to Administrative Code Sec. 70-57, the Planning and Zoning Division is hereby directed to prepare a map designating the street name change and to file such map with the City Clerk. Said map shall be made part of the Official Street Name and Property Numbering Maps of the City of North Port, Florida.
- 3.02 The Neighborhood Development Services Department is hereby directed to contact all pertinent organizations and departments and notify them of the change of street name on the Official Street Name and Property Numbering Map of the City of North Port, Florida.

**SECTION 4. CHANGE TO STREET SIGNS**

- 4.01 Upon adoption of this ordinance the City's Public Works Department shall be responsible for ensuring that the West Villages Improvement District causes the name on all signs along the above-cited section of South West Villages Parkway to be changed to Playmore Road.

**SECTION 5. SEVERABILITY**

- 5.01 If any section, subsection, sentence, clause, phase, or portion of this ordinance is for any reason held invalid or unconstitutional by any court of competent jurisdiction, such provision shall be deemed a separate, distinct, and independent provision and such holding shall not affect the validity of the remaining portions hereof.

**SECTION 6. CONFLICTS**

6.01 In the event of any conflict between the provision of this ordinance and any other ordinance or portions thereof, the provisions of this ordinance shall prevail to the extent of such conflict.

**SECTION 7. EFFECTIVE DATE**

7.01 This ordinance shall take effect immediately upon adoption by the City Commission.




