Dennis Goral, Project Manger, with Wildan Financial Services, provided a presentation including user fee background, user fee study, methodology components, typical fee composition, user fee policy considerations, fee types reviewed, city-wide fees, utility user fees, road and drainage fees, police fees, fire fees, emergency medical services fees, parks and recreation fees, final considerations, and development services fees next step.

Commission question and discussion took place regarding user fees study methodology, Parks and Recreation, citizen inquiries on details, Warm Mineral Springs, nonresident fees, Florida Law fees, raising fees vs. lowering taxes, service levels, cost-effective strategies, maximum fees, uncharged services, Accela investment, police fees, city-wide fees, fee caps, cost recovery, Parks and Recreation recovery rates, avoiding citizen upcharge, fiscal year (FY) 2026 budget, revenue, service quality, efficiency policies, budget-based user fee determinations, increased efficiencies, Florida Power and Light (FPL) fees, community center costs, cost offsets, tax savings, citizen benefits, fee balance, past city-wide studies, loans, spending vs. charging balance, North Port fee history, demand data, gym and aquatic center access, direct and indirect costs, mandated building fees, funding, department-wide expense cuts, service cancellations, Fire Department, depreciation, maintenance, building upkeep, city employees, and awards programs.
