Approach to Project/Project Control/ Resources

Background

The City of North Port, Sarasota County's most populous municipality and the 7th largest City in the State of Florida by geographic size, has about 78,000 residents and continues to see steady population growth. The City is located in the southern section of Sarasota County on Florida's Gulf Coast midway between Tampa and Naples and comprises about 104 square miles of area. The City has 70,608 platted residential lots, 813 miles of roads and 164 miles of man-made canals. The City currently serves over 25,233 water customers, 19,792 wastewater customers and 54 bulk residential and commercial reclaimed water customers.

The City provides public safety, recreational, public works, public utilities, planning, engineering, economic development, and general administrative services for its residents. The City recognizes the need to plan for the increased costs to serve its growing population while maintaining its level of service.

The City's funds include the General Fund, several districts (Road & Drainage, Fire Rescue, Solid Waste), Water & Sewer Utilities enterprise fund, an internal service fund, and various other capital and nonmajor funds. As charges for services are the majority of the City's revenue for both governmental and enterprise activities, the City recognizes the need to update these charges periodically, so as to ensure that they adequately recover the cost of these services.

The goals of the professional services requested are for the City to:

- Determine the adequacy of its current rates and fees to cover the cost of providing services, and
- Review/update its methodology to obtain the desired level of cost recovery while remaining
 consistent with laws, regulations, statutes, and rules that govern the collection of fees, rates, and
 charges by public entities.

SCS performs the full range of consulting services for municipal clients, developing financial sustainability solution, including **revenue sufficiency analysis**, rate studies, cost allocation, **assessment development**, benchmarking, and **fee analysis**. Our staff has the ability to offer an independent evaluation of fees and charges

that allow municipal entities to realize their financial goals while meeting their operational, capital, debt service coverage, and reserve requirements.

We excel at communicating the results of our analysis in public presentations and workshops with county commissions, city councils, authority boards, and citizen's advisory boards to gain acceptance of the recommended financial sustainability solutions.

SCS has developed an interactive modeling approach that allows input from the City as we develop financial solutions customized to your financial dynamics. The results are displayed in a simple format that allows for easy understanding and future updates. During the meetings with City staff, we project the models onto a monitor or viewing screen, and work with key staff to create financial solutions that allow the City to meet its financial goals and regulatory requirements while minimizing the impacts to its customers. The identified rates, fees, and assessments, projected cash flows, and assumptions are then presented in workbooks of detailed schedules.

Our Approach

Updating your charges for services begins with our suite of utility **rate and financial planning models** that we customize to reflect the City's available funds, budgeting and actual spending, customer information, and capital program. The models are designed to:

- Identify assumptions and variables
- Examine historical trends and performance
- Forecast financial requirements
- Test alternative what-if scenarios and/or methodologies
- Calculate cost of services
- Determine the sufficiency of current rates to recover the cost of services
- Design updated rates based on cost to provide services and influence behavior

Our detailed approach and planning tools will allow our project team to **work closely with City utility staff**, finance staff, and City Administration to develop and get support for a long-term financial plan. We will utilize our models in interactive work sessions with City staff to review what-if scenarios and develop strategies to implement a sustainable rate and financial plan.



Steps to a Successful Financial Study

There are several steps to calculating cost-of-service based rates. This section describes the ratemaking process and how we will work with the City to develop rates tailored to your system dynamics, diversion initiatives, and service levels. The steps also detail interaction with City staff, administration, elected officials, and the public that are required to facilitate the desired outcomes for your study.

Compile and Review Existing Information

We will begin our study by scheduling a **kickoff meeting** with our team and City staff to discuss key
issues, near and **long-term goals**, and metrics that
you consider to be most important to your financial
performance. At this meeting we will also distribute our
data request, **discuss the items required for our analysis**, and the platform we will use for data
transfer.



We will establish who will be involved in the process,

the **key members of our team and your key staff**, and discuss the **project schedule** for interactive work sessions with your staff, meetings with your Council, and final deliverables.


We will work with City staff to identify and obtain all information relevant to understanding your existing operations and costs for provision of service to customers. Once we start to receive the data, we will begin an in-depth review. We will also review any other data provided and remain in contact if we need clarification prior to our first interactive work session. Items we request may include:

- Historical and current rates/fees/assessments, including miscellaneous or one-time fees
- Account/customer billing information and/or parcel data
- Customer service level / disposal characteristics
- Fund balances
- Historical and budgeted revenues and operating expenses
- Debt service schedules and coverage requirements
- Capital improvement plan and fleet/equipment inventory
- Current staffing and projected future hiring
- City ordinances and policies relevant to the analysis
- Legal and financial concerns and/or regulatory and policy restrictions

Revenue Sufficiency & Financial Requirements

For almost any financial study, the process begins with identifying the revenue requirement. SCS uses an interactive modeling approach that allows input from you as we develop **customized financial solutions**. To determine your financial requirements, we perform a revenue sufficiency analysis to determine the long-term sustainability of your revenues, including a long-term **financial management plan and associated plan of revenue adjustments**.

During meetings with your staff, we display the models and work with you to **test multiple** "what if" scenarios that consider your financial sensitivity to changes in various variables. For example, we can test the impact of changes to your capital program costs and timing, and the associated impact on operating expenses and staffing requirements. For each scenario considered, we identify the necessary revenue adjustments, including any borrowing that may be required, and the associated financial, fund balance, and customer impacts.



We will also evaluate capital funding alternatives, including cash funding, debt funding, grants, or any other financing alternatives the City is considering. The results are displayed in a simple, graphical format that allows for easy **comparison of scenarios**. Some of the steps in this process are detailed in the following sections.

Revenue Projection

We examine a **multi-year history** of revenues, billing history, budgeted revenue to actual receipts, **financial trends**, and financial policies that affect the revenues of the utility. We also consider **revenue optimization and revenue diversification strategies**. To project revenue from customer charges, we evaluate historical billing data, assessment rolls, revenues, and population growth to estimate future **growth projections** that will affect your rate revenues.

Expense Projection

To project your revenue requirements, we review your historical budgeted and executed operating expenses, all planned capital improvements and associated funding sources, existing debt service and coverage ratios, available and recommended operating, capital, and debt service reserves, and any financial policies and reserve requirements dictated by policies of the City. We also **consider your goals to address during the study**, such as cash reserve targets, operational changes, or hiring needs.

We study **changes in capital and labor costs** and how this will affect your expenses. Using cost escalators, we estimate your future expense increases and the nature of any expenses that may be contractual or one-time/temporary. As we tailor our model to your operations, we identify any other **issues or questions affecting financial performance to discuss with you** during our interactive meetings.

Capital Program Review

One of the largest expenditures driving the need for revenue is the cost of capital outlay required to meet **current** and future service needs and regulatory requirements. In addition, there are significant renewal and replacement cost requirements to preserve the reliability and useful life of your infrastructure and other assets. And implementing new programs often requires additional infrastructure, equipment, or other capital expense.

We perform a detailed review of your current capital program and the **anticipated sources of funds** available to pay for these projects. This discussion of funding is important to reducing the impact of capital on rates. Recognizing this, we will:

- Review the level of your budgeted capital spending vs needed capital investment,
- Consider the priority of individual items within your capital plan,
- Review all restricted and unrestricted funds available for projects,
- Discuss timing of project expenditures, and
- Consider external funding sources, such as grants or loans, that may mitigate rate impacts.

In meetings with City staff, we will review the level of capital or types of projects the City historically cash funds from revenues. We will evaluate the pros and cons of alternative capital funding practices, and financial considerations associated with leveraging debt financing.

We will consider whether the City could adapt its use of cash and debt funding to maximize available cash reserves, improve the long-term stability of rates, and limit risk. Working with you, we will develop a **recommended capital spending and funding plan** for the identified capital and future capital needs.

Financial Management Plan

Based on our analysis and interactions with staff, we now have a **forecast of your system growth** and **anticipated revenues under your current rates**. We also have a **projection of operations and maintenance** expenses, capital investment, debt service payments, and the resulting fund balances in each year of the projection period.

The final step is to review the scenarios the City may wish to consider for project timing and funding, policy changes, or sensitivity to changes in any of the assumptions used in the analysis and then **develop a long-term plan of rate adjustments** for each scenario. Working with you, we identify the scenario that best reflects your **anticipated and desired outcomes while minimizing impacts** to your residents.

This plan provides the revenue requirements used as the basis for updating your rates/fees/assessments.

Rate/Fee/Assessment Development

As required by the studies for which we are engaged, we will perform the following tasks:

Rate Structure Analysis

To begin a rate structure analysis, we examine the City's current rates/fees and identify any structural adjustments to consider in developing the City's new rates. We obtain historical billing data and/or property data and analyze current billing practices. The test year revenue requirement is based on the results of the revenue sufficiency analysis and we use this revenue requirement and the results of the billing data analysis in the development of an updated rate/fee structure. In developing this structure, we consider the cost of services provided, customer impacts, and the City's desire to incentivize customer behaviors.

During an interactive meeting with you, we calculate rates based on the current structure and recommended adjustments. We discuss the basis of the recommendations and test the sensitivity of the rate changes to various customer classes and demand characteristics. The goal is to develop a structure that will accurately reflect the dynamics of your operations while equitably distributing costs across your customer classes.

Impact Fees

Impact fees, often referred to as capacity charges or system development fees, are charges levied on new development to reimburse local governments for the capital costs of constructing public facilities required to provide service to that development. Impact fees are a mechanism for growth to pay its own way, thus minimizing the cost to existing residents for new or expanded facilities required to serve new development.

Impact fees are well-defined in Florida statutes and relevant case law has guided best practices. These case law determinations generally agree that a rational nexus must exist. The test is that:

- 1. There must be a reasonable connection between the need for additional facilities and the growth resulting from new development,
- 2. The fees charged must not exceed the proportionate share of the cost to support the development paying the fee, and
- 3. There must be a reasonable connection between the expenditure of the fees collected and the benefits received by the development paying the fees.

Additionally, the level of service paid for by these fees cannot be greater than the existing level of service in the system.

Much as in other forms of ratemaking, impact fees require determining the cost of development-related improvements and then equitably allocating those costs to the various types of new development.

As part of this process it is important to determine how much, if any, of the current system is available to serve growth and how much, if any, capital investment will be required to continue to do so. Several common approaches for calculating impact fees are:

- Incremental Cost In communities that have limited existing capacity, specific costs for future improvements needed to serve new development are identified in a capital improvement program (CIP). The fee calculation is based on the identified cost and added capacity of the improvements.
- **System Buy-In** This excess capacity approach is used for existing facilities that have been oversized and have excess capacity available. The fee calculation is based on the replacement cost of the system's assets and existing system capacity available for new customers.
- **Hybrid** This combined approach recognizes the use of existing capacity as well as future projects that will be required to serve growth. This approach is most appropriate when there is excess capacity in the current system that can accommodate some growth, but the CIP also includes projects that will provide system expansion, required to support growth.

System and CIP analysis includes:

- Reviewing CIP and existing debt service for expansionary projects, or portions thereof
- Analyzing fixed asset inventories, including calculating replacement cost and remaining useful life
- Considering other documents the City may have, determines the portion of the City share of those assets, if any, that may be used to serve new development
- Identifying other funding sources such as grants or developer contributions that may have paid for part of system costs, or a portion of the system that serves specific developments and will not benefit new development

All these approaches/analyses are considered in updating impact fees.

Non-Ad Valorem Special Assessments

Much like impact fees, Florida statutes and case law governing special assessments have defined the best practices for methodology and assessment calculation. The case law has defined two basic requirements:

- 1. The service and facilities paid for by the assessments must convey a **special benefit** to the real property subject to the assessment.
- 2. The total amount imposed must be fairly and reasonably apportioned among the affected properties.

We start with the revenue requirement from the revenue sufficiency analysis as described above. Then the analysis consists of the following elements:

Finding of Benefit

In order to determine the assessments for each parcel, we first review the City's property data. We determine the parcels that will receive special benefit from the project and the type/level of benefits received.

Cost Apportionment

Then we consider the methodology to be used in apportioning the revenue requirement to the benefitting parcels. We will populate our assessment model. The model allows us to review the methodology and revenue requirements and test the impacts to various property uses and sizes.

In a meeting with the City, we will discuss any recommended changes to the existing methodology and recommend a methodology that is in keeping with the City's methodology requirements, case law, and Florida Statutes.

Assessment Calculation

We then calculate the assessments for each parcel at 100% cost recovery and other levels of cost recovery. To the extent desirable, we will discuss phasing in the full cost recovery over time.

Assessment Roll & Future Updates

Upon completion of the analysis, we work with the Sarasota County Tax Collector to deliver the assessment roll in a timely manner, in the format required. Assessments have to be provided to the Tax Collector annually, applying the methodology to parcels based on property use and characteristics. We can assist the City in these updates.

Passing non-ad valorem special assessments also requires a mailing in advance of the public meeting for adoption. We can assist the City in this mailing as well.

Other Fees

We will obtain a list of the City's current user fees and charges. To the extent required, we will examine the labor, overhead and indirect costs, materials, and equipment costs necessary to provide these services and calculate the updated fees at 100% cost recovery. We can meet with members of staff from various departments to determine the level of effort, supplies, and equipment required for each task. We will identify other charges that the City might consider based upon the services provided and fees charged by other cities. We will discuss the desired cost recovery for each fee with the City. If the City feels that 100% cost recovery is not feasible all at once, we will discuss phasing in the full cost recovery over several years.

Rate/Fee Comparisons

For various rates and fees calculated, we can conduct a survey of comparable entities to determine the City's charges relative to these other entities. We discuss the results of these surveys in meetings with City staff and include them in presentations to the Council and public and in our reports.

Presentation of Results & Implementation Assistance

Public Meetings

In addition to written memorandums, we can develop a **PowerPoint presentation** summarizing the findings of any analysis and can attend **meetings with the City Council and/or public** to present the results of our

analysis. This is the first time many of the residents will hear the details of the study performed. It is important to convey that the City is acting in the best interests of its residents. We can communicate:

- The responsibility of a City to provide **essential services** for its residents
- The **key issues** you are facing and the associated costs
- The methodology and basis for calculating rates/fees/assessments, including the equitable distribution of costs

Ordinance/Policy Review


As part of financial studies, we discuss with City staff any policies/ordinances/resolutions that may be out of date or need to be updated due to the proposed rates/fees/assessments. We also consider additional items that could be included in your ordinances/resolutions in the future.

This is an appropriate time to also discuss other **City allocations and policies** that can be updated or have been analyzed during the study, such as **working capital reserve targets**, capital/rate stabilization reserve funding, indirect administrative cost allocation to departments/funds, etc.

We will discuss policy recommendations and any other recommendations with City staff and can be available should the City want us to work with City attorneys to update ordinance or policy language.





Solid Waste Rate Study & Expert Witness Services

Atlanta, GA

The Story

Historically, the City's solid waste operations, although an Enterprise Fund, have not been sufficiently funded, resulting in significant indebtedness to the General Fund. The City charges solid waste fees to its customers on their tax bills and in 2020 engaged SCS to update their solid waste rate methodology and calculations, as well as to consider other billing methods that may be appropriate for customer billing.

The Process

The study first involved a financial projection over a multi-year period. The

analysis considered indebtedness to the General Fund, the basis for that calculation, and repayment. Part of this process involved conversations with Finance regarding the repayment of the indebtedness, as well as General Fund reimbursement for certain solid waste services and common good services not included in the solid waste and recycling rates. Once we developed a plan of rate and revenue adjustments, we performed a cost of service analysis.

Using staffing information and extensive work with staff, we allocated employee salaries and equipment time to each of the various solid waste services and other functions that the City provides. With this information, billing system information, parcel data, annual tonnage data, and other input from staff, we apportioned all of the City's budget into each of the identified functions and services. These then became the revenue requirement for updating the rate components and reimbursable services.

The study involved significant efforts to understand the City's current billing system, customer classes, customer database for collections, and rate structure, including the City's ordinance and Charter. We identified questions/issues in the City's billing system and methodology and worked extensively with staff and GIS to identify the customers and levels of service and calculate new rates. There were legal concerns for which we were engaged for expert witness services as required and for which we provided input to City attorneys regarding rate methodologies and billing.

The Results

Working with City staff and attorneys, we developed a methodology to charge for solid waste and recycling collection, and for various special services such as street sweeping and dead animal collection. We worked with City attorneys to update the City's Charter and ordinances, and present the results of the study and several rate recommendations for the special services in public meetings. The City adopted the recommended rates for solid waste and recycling and the Council chose to adopt the ad valorem method for funding the special services not related to curbside solid waste/recycling collection. SCS continues to work with the City in support of updating their rates, billing system, and operational processes to improve efficiency, accuracy, and ease of future billing.



Water, Wastewater, and Solid Waste Utility Rate & Fee Study (and Annual Updates), Impact Fee Study

City of Sheridan, Wyoming

The Story

The City operates a water utility, wastewater utility, and a landfill and solid waste collections utility. The three operate as individual enterprise funds, although there are some payments between them for billing and handling of sludge. Some large alternative water supply and landfill projects are planned in the near future, requiring a plan for the financial stability of its funds over a multi-year projection period. The City has engaged SCS since 2019 for rate/fee services.

The Process

SCS initially performed a rate study and tipping fee study. We also worked with City staff and Council to consider options to incorporate a Pay-As- You-Throw

program option into the City's solid waste rate structure. Annually, SCS updates the revenue sufficiency analysis portion of this study for the water, wastewater, and solid waste utilities.

In the revenue sufficiency analysis, SCS conducted an integrated analysis to evaluate the City's various rate/fee revenues, model the dynamic interaction between the enterprise funds, and determine the level of rate increases necessary to meet all of the current and projected financial requirements over a ten-year projection period.

The most recent update involved creating a 5-year rate plan for the utilities that would be presented to the City Council. The study concluded that, while the City's water rates are sufficient throughout the 5-year plan, wastewater and solid waste rates would not be sufficient to fund all of its ongoing operations, capital, and reserve requirements. We created a financial management plan for each utility to address the revenue shortfall.

The City also engaged SCS to update its Plant Investment Fee (PIF), which is an impact fee, for water and wastewater. The Council had recently adopted a master plan that stressed the need for affordable housing in the City, so they wanted to address the PIFs paid by residential properties of various lot and home sizes.

The Results

Several public meetings with Council were held to address the rate plan recommendations and policies regarding reserve levels for each of the funds. City Council adopted the 5-year financial plan recommendations.

Another public meeting addressed the PIF and presented several methodologies that would allow smaller residential homes with smaller irrigable lot sizes to pay less than larger homes with larger irrigable lot area.

SCS continues to work with the City in another study to update its operational/cost relationship with the Sheridan Area Water System Joint Powers Board and consider taking over that system.

Water Capital Assessment & Update Stormwater Rate Study

Village of Pinecrest, Florida The Story

Miami-Dade County owns, operates, and maintains a public potable water supply system that serves much of Miami-Dade County, including much of the Village of Pinecrest. The County agreed to serve the remaining parcels in the Village that are not currently on the Water System if they connect, but did not have plans to extend a water line to serve these parcels.

The Village also provides stormwater services to its residents and recovers the cost to provide services via a fee on the residents' property tax bills.

The Process

SCS developed a Water Capital Assessment to recover the capital costs of installing water lines to the benefitting parcels based upon allocation of benefit.

We also assisted the Village in creating the parcel roll with the amounts to be billed on the annual property tax bill as a special non-ad valorem assessment. As there was a delay before bond issuance and assessment implementation, we further assisted in an assessment and roll update in subsequent years.

SCS also developed updated stormwater rates by determining the revenue sufficiency of the stormwater utility and developing a methodology to apportion the costs to provide services proportionally to the services received by each parcel. The study considered updating the Village's Equivalent Residential Unit (ERU) or implementing an alternative methodology for rate calculation.

As part of this process, we worked closely with the Village's attorneys, engineers, and financial advisors.

The Results

As part of the process to adopt new assessments or fees to be charged on the property tax bill, SCS presented to the Village Council and public in several meetings. This helped to gain support and public acceptance of the changes.

Discussions with the Council also resulted in use of American Rescue Plan funds to pay for a portion of the capital for the water project.

Stormwater rate adjustments and alternative methodologies were presented to Council for adoption.
