SUBJECT: **REVISED - RFB NO. 2026-18 Duty Handguns and Accessories**

Section I: Background:

REVISED: On April 6, 2026, Lou’s Police Distributors, Inc. notified the City of a pricing error in their bid submission. In accordance with standard public procurement policies and to maintain the integrity of the competitive bidding process, bidders are not permitted to modify pricing after the formal bid opening. As a result, Lou’s Police Distributors, Inc. was deemed non-responsive and disqualified from this solicitation.

HISTORY: The solicitation was broadcast to 36 suppliers plus 3 supplemental suppliers. Bid opening was held on March 25, 2026, three (3) bids were received and reviewed for responsiveness. The results of the due diligence review and tabulation are attached. Below is the bid amount from contractors that submitted:

REVIEW: Please review the submittals which were provided to Chelsey Rodgers during the Bid Opening. Purchasing has reviewed the submittals and has determined that GT Distributors, Inc. is the apparent lowest responsive and responsible bidder following the disqualification of Lou’s Police Distributors, Inc. (see attached tabulation). A responsive submittal is one which conforms in all material respects to the solicitation. This quote contains no exceptions or deviations from the terms, conditions, and specifications.

CRITERIA FOR AWARD: The award of this RFB shall be to the lowest responsive, responsible bidder meeting or exceeding all of the specifications. Other considerations in the award of this bid shall be the number of days required to deliver after receipt of purchase order and local preference.

The City reserves the right to reject the bid proposal of any bidder who has previously failed to perform properly, or on time, contracts of similar nature; or who is not in a position to satisfactorily perform the contract.

Section II: Review and Recommendation:

Police Department staff shall review the submittal to determine if the bidder is responsible. A responsible person, company or entity is determined to have the capability in all respects to fully perform the contract requirements and has the integrity and reliability which will assure good faith performance and the capacity and capability to perform in accordance with the specifications. Additionally, verify the references as applicable **(Section II B & C, below)** and make sure the qualifications which were specified in the solicitation have been met. Please complete and sign this form and attach your recommendation along with the recommendation of the Department for Finance Director’s approval. Upon receipt of this form, Purchasing will post Notice of Intent (NOI) and you may initiate the contract process.
