

ORDINANCE NO. 2020-24

AN ORDINANCE OF THE CITY OF NORTH PORT, FLORIDA, AMENDING CHAPTER 3 OF THE CODE OF THE CITY OF NORTH PORT, FLORIDA AND CREATING SECTION 3-15 REGARDING AN ADDITIONAL HOMESTEAD EXEMPTION FOR PERSONS SIXTY-FIVE (65) AND OLDER WITH CERTAIN INCOME LIMITS; PROVIDING FOR CONFLICTS; PROVIDING FOR SEVERABILITY; PROVIDING FOR CODIFICATION; AND PROVIDING AN EFFECTIVE DATE.
