ORDINANCE NO. 2014-05

AN ORDINANCE OF THE CITY OF NORTH PORT, FLORIDA, REPEALING RESOLUTION NO. 10-R-36; ADOPTING CHAPTER 4, BOARDS AND COMMITTEES, ARTICLE IX, OF THE NORTH PORT CODE ESTABLISHING THE SISTER CITY ADVISORY COMMITTEE; PROVIDING FOR SEVERABILITY; AND PROVIDING AN EFFECTIVE DATE.

NOW THEREFORE, BE IT ORDAINED BY THE CITY COMMISSION OF THE CITY OF NORTH PORT, FLORIDA:

SECTION 1 - REPEAL

1.01 Resolution No. 10-R-36 is hereby repealed.

SECTION 2 - ADOPTION OF ARTICLE IX, OF NORTH PORT CITY CODE ESTABLISHING THE SISTER CITY ADVISORY COMMITTEE

2.01 The North Port City Commission hereby adopts Part II, Chapter 4, Boards and Committees, Article IX, of the City Code, establishing the Sister City Advisory Committee, which is attached hereto as Exhibit "A."

SECTION 3 - SEVERABILITY

3.01 If any section, subsection, sentence, clause, phrase or portion of this Ordinance is for any reason held invalid or unconstitutional by any court of competent jurisdiction, such provision shall be deemed a separate, distinct and independent provision and such holding shall not affect the validity of the remaining portion thereof.

SECTION 4 - EFFECTIVE DATE

4.01 This Ordinance shall take effect immediately upon its adoption.

EXHIBIT A

CHAPTER 4, ARTICLE IX, SISTER CITY ADVISORY COMMITTEE

Sec. 4-180. Establishment

The Sister City Advisory Committee is hereby created and established.

Sec. 4-182. Meetings

The Committee shall meet at least annually, but may hold additional meetings as needed.

Sec. 4-183. Power and duties

A. The Sister City Advisory Committee, shall:

1. Make recommendations to the City Commission on the establishment or discontinuance of specific Sister City relationships.
2. Recommend, coordinate, facilitate, promote, organize, conduct and implement events, outreach and promotions with designated North Port Sister Cities.
3. Recommend, communicate with, and coordinate with other agencies and organizations, including but not limited to appropriate embassies, governments and Sister City International, which will facilitate a North Port Sister City relationship.
4. Recommend to the City Commission other actions that would be appropriate for fostering and improving the relationship with designated North Port Sister Cities.
5. Perform such other duties as directed by the City Commission.
