



Figure 4. Part of the Design of Price Trailhead Section of Connector







Figure 4. Portion of route from proposed path's arrival at Trionfo Avenue, heading west towards Warm Mineral Springs Park.

**Exhibit I: State Outdoor Comprehensive Recreation Plan** 

The Florida State Comprehensive Outdoor Recreation Plan (SCORP) "describes a vision for an ideal, but as yet unrealized, outdoor recreation system for the Sunshine State" (SCORP p. 29). Its vision includes four priority areas: 1) Health and Well-being; 2) Public Access, Accessibility and Connectivity; 3) Economic Opportunities, Adventure Travel and Ecotourism; 4) Resource Management and Stewardship.

The Warm Mineral Springs Connector (WMSC) will directly realize all four priority areas outlined in the state's vision. The WMSC will allow citizens of the City of North Port to engage in "high quality outdoor recreational experiences" by connecting them to the Legacy portion of the SUN Trail system. This will help the City develop a culture of wellness and healthy activity City-wide. Regarding Priority Area 2, the WMSC will "improve overall connectivity and infrastructure" (SCORP p. 31), enhance bicycle and pedestrian safety, "improve physical access to outdoor recreation opportunities" (SCORP p. 31).

Regarding Priority Area 3, economic studies consistently find that trails provide real economic benefits and investment returns to communities. One example of this is by connecting the Warm Mineral Springs Park and the City to the SUN Trails system, it will allow the City to participate in and attract adventure travel users from through the chutney and world to SW Florida. And as the SCORP notes, "the widespread conclusion that outdoor recreation has a sizable economic impact" (SCORP 22). This is especially true when the Connector is considered as part of the rehabilitation and preservation of Warm Mineral Springs Park, part of the vital heritage of the area.

Regarding Priority Area 4, connecting WMS Park to the greater SUN Trails System will allow the City to "merge environment-based outdoor recreation with a focus on culture and heritage" (SCORP p. 31). Eighty-five percent of respondents to the 2023-2027 SCORP survey indicated that they participated in trail activities. The demand for more bike trails by full-time residents of Florida is clearly extremely high.

#### DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE

Warm Mineral Springs is a large, free-flowing mineral water-fed collapsed cave. The surface configuration of the spring is nearly circular, having an approximate diameter of 275 feet. The average daily water flow of the spring is between 7 and 9 million gallons (Ferguson, et al., p. 149). The surface outlet located on the southwestern edge of the spring forms Salt Creek, which empties into the Myakka River some two miles to the southwest. The year-round surface water temperature is 86°F. which distinguishes it from other Florida springs. The high percentage of dissolved minerals has stimulated the commercial development of the spring. Warm Mineral Springs is presently operated as a tourist-oriented health spa.

The environment of the area immediately surrounding the springs was substantially altered in the early twentieth century to accommodate commercial exploitation of the lumber and turpentine industry. The original vegetation consisted of pine, oak, palmetto palm, mangrove, and rush; however most of this has been removed. A few isolated pines, palmetto palms, and ornamental shrubbery presently comprise the extant vegetation.

The subsurface features of Warm Mineral Springs have only been partially explored. The main body of the springs is an hourglassshaped sinkhole, with a maximum depth of 220 feet. Between 35 and 80 feet from the surface are a number of small ledges which encircle the basin. Near the bottom of the north side of the springs a tunnel Much of this tunnel network is unexplored; however, complex opens. it is known that two water sources, one cool and the other hot, merge in the main tunnel. The warm water source is the most likely vehicle for the dissolved minerals, and is probably derived from very old geologic beds (Ferguson, et al., pp. 10-11).

A number of the ledges around the basin contain a series of shallow caves, which exhibit huge columnar stalactites and stalagmites. These formations occurred at a time when the water level was a great deal lower than present (Royal and Clark, p. 285). It is also postulated that these ledges and caves were well suited for, and indeed were used as, burial sites for Early Man.

#### STATEMENT OF SIGNIFICANCE

Warm Mineral Springs first came to the attention of professional archaeologists in 1960, when divers began to retrieve human skeletal materials from the ledges (Goggin, p. 80). In the same year William Royal and Eugenie Clark published an article detailing additional skeletal and cultural material recovered (p. 285). They recovered enough human bones to account for seven individuals. Artifacts included "two long bone needles, an antler shaft wrench or atlatl weight, a bone pestal, marked deer bones and antlers, and part of a fossil shark's tooth with a chipped edge" (Royal and Clark, p. 285). All these remains were recovered from a depth of 35-40 feet, along the ledges or in the shallow caves. Also recovered was a fragment of charred red mulberry wood, which was dated by Carbon-14 at 8,000 B.C. ±200 years (Royal and Clark, p. 286).

Further testing and excavation were sponsored by the Florida Division of Archives, History and Records Management. Early in 1972, Carl Clausen, Marine Archaeologist, conducted preliminary investigations. In the stratified deposits of the shallow caves, Clausen excavated fragments of human bone, charred wood, and organic leaf deposits. Nine Carbon-14 samples produced dates ranging from 8920 ±190 to 10,630 ±210 B.P. (Kigoshi).

In February 1973, W. A. Cockrell, Florida State Underwater Archaeologist, recovered human skeletal material, including portions of a skull, from stratified deposits in a cave 45 feet below the surface of the water. Also found in the underwater cave site were small animal bones as well as completely preserved oak and hickory nuts, and leaves. The remarkable preservation of the deposits has been attributed to the lack of dissolved oxygen in the water (Cockrell, 1973, p. 3). Eighteen conclusive Carbon-14 samples taken from leaf deposits surrounding the skull under tightly controlled conditions clustered at 10,200 ±145 B.P.

While collecting pollen samples in October 1973, Cockrell found an extremely well worked marine shell spear-thrower spur, with adhesive still attached. The location of the spear-thrower was 30 cm. to the interior of the cave from where the human skeletal material was removed (Cockrell, 1974).

The report submitted by Archaeological Consultants, Inc. (ACI) concerning the above referenced properties has been reviewed by our Historic Preservationist Carl Shiver. Despite some alterations to the buildings, our office feels that they are historically significant and are eligible for listing in the National Register of Historic Places (NRHP).

The proximity of the two buildings lends them to be nominated as an individual property with two related resources. Together, the Spa and Cyclorama comprise the Warm Mineral Springs Building Complex Resource Group (8SO7026). This resource group is considered potentially eligible for the NRHP at the local and state level under Criterion A in the areas of social history and entertainment/recreation, and at the local level under Criterion C in the area of architecture.

Jack West, a notable member of the Sarasota School of Architecture, designed the Spa and Cyclorama and referenced the shape of the Warm Mineral Springs pool in his design and layout. The two buildings were originally constructed to house exhibits for the Quadricentennial, a statewide celebration of the 400th anniversary of St. Augustine's founding. The Cyclorama featured paintings, statues, and a narration that told the story of Spaniard Juan Ponce de Leon's 16th century explorations of Florida and his rumored quest for the Fountain of Youth. It is notable that only an estimated 30 other cycloramas now exist in the world. Our searches found only two cycloramas located in the United States, which depict the Civil War battles of Atlanta and Gettysburg, and are located in their respective cities.

In summary, our office concurs with ACI's opinion that the Warm Mineral Springs Building Complex Resource Group (8SO7026), comprised of the Spa and the Cyclorama, is potentially eligible for listing in the National Register of Historic Places as one individual property of two related resources rather than as a historic district.
