

I, sec. 24 of the Florida Constitution. This request is for public records in the possession of the City of North Port ("the Agency"), its employees, elected or appointed officials, attorneys, lobbyists, agents, contractors or representatives, regardless of the location of those records. We understand that a citizen is not required to make a written request to obtain public records under the Act, but we want to be clear what we are seeking from you. Additionally, a written request for records also serves to fulfill any notice requirements set forth in the Act, including, but not limited to, section 119.12(1)(b), Florida Statutes. This written request satisfies the five-day notice provision contained in section 119.12(1)(b). We will not provide any additional notice of your statutory obligation to timely furnish responsive records. Accordingly, we hereby request production of any emails and text messages made, sent or received in connection with the transaction of official business or the rendition of services on behalf of the Agency, including by any employee, elected or appointed official, attorney, lobbyist, agent, contractor, or representative of the Agency that relate to: 1. Any individual associated with Mattamy Homes; 2. Any individual associated with Carlton Fields; 3. Any individual associated with the Florida Home Builder Association; 4. Any individual associated with Senator Keith Perry or his legislative staff; 5. Any individual associated with Representative Persons-Mulicka or her legislative staff; 6. Any individual associated with Kraig Conn. This requests seeks all responsive records during the period between October 1, 2021, through October 31, 2021. If any portion of this request is readily available, please furnish that record immediately regardless of whether other portions of the request are not readily available. The term "record" or "public records" as used herein shall have the same meaning and definition set forth in section 119.011(12), Fla. Stat., and also includes responsive records in native digital format (email, text, sms, mms, .doc, .docx, voicemail), transmitted electronically. Stat., and notify the third party of the request for public records and the statutory obligation to provide them within a reasonable period of time. Pursuant to section 119.07(1)(d), Fla. Stat., "[a] person who has custody of a public record who asserts that an exemption applies to a part of such record shall redact that portion of the record to which an exemption has been asserted and validly applies, and such person shall produce the remainder of such record for inspection and copying." There are a number of archaeological sites in the North Port area some of which were mapped in the 1970s before the mapping technology was very good, i.e. they guessed where they were and drew it on a map! In doing these surveys we have realized that the location of some of these sites may be recorded in correctly. I have attached a figure below showing the blue location the sites as they are recorded and the red locations where we have tested and pinkish locations where we have found evidence of these sites. But as you can see from my map we don't have all the info. The City of North Port has an excellent ordinance that not only allows for development, but also a better understanding of the archaeological past and protection of key sites when warranted. There are several other archaeological firms that have conducted surveys in this area, but since very few of these surveys are ever filed at the State in the Florida Master Site File (including our own), I don't have a way to see those reports and their results. Some have been shared with me by Sarasota County and some of the other firms (I am currently working to add that info to my map), but I am sure there are more out there. Ultimately, I hope to combine results to not only help us when we are doing archaeological surveys but to also help the City in tracking the progress and understanding the sites, in whatever way helps them best. I understand the archaeological reports are part of the building permit process, but I believe the reports are exempt from public records due to the sensitive nature of the information. Is there some way that we could obtain copies of the reports though, so we can add the data to ours and in turn provide some updated information to the City? I am glad to send someone to physically search and copy things or whatever method you think might be best. I know this is an unusual request and I would be happy to discuss it so I can better understand how I can make the request without it being too onerous to you or your staff.
