## RESOLUTION NO. 2024-R-17

**A RESOLUTION OF THE CITY COMMISSION OF THE CITY OF NORTH PORT, FLORIDA, AMENDING THE NON-DISTRICT BUDGET AND CAPITAL IMPROVEMENT BUDGET FOR FISCAL YEAR 2023-2024 FOR DESIGN OF A POLICE HEADQUARTERS; PUBLIC ART PROJECTS; EMERGENCY OPERATIONS CENTER; CAPITAL CONTRIBUTION TO WEST VILLAGES IMPROVEMENT DISTRICT; MORGAN CENTER REROOF AND TWO TIRE BALANCERS IN THE AMOUNT OF \$20,359,097; PROVIDING FOR FINDINGS; PROVIDING FOR POSTING; PROVIDING FOR CONFLICTS; PROVIDING FOR SEVERABILITY; AND PROVIDING AN EFFECTIVE DATE.**

**WHEREAS**, Resolution No. 2023-R-59 approved the Non-District Budget and Capital Improvement Budget for fiscal year 2023-2024; and

**WHEREAS**, Florida Statutes Section 166.241(7)(c) requires that a budget amendment be adopted in the same manner as the original budget; and

**WHEREAS**, the City Commission desires to amend the Non-District Budget and Capital Improvement Budget for supplemental appropriations.

**NOW, THEREFORE, BE IT RESOLVED BY THE CITY COMMISSION OF THE CITY OF NORTH PORT, FLORIDA:**

### **SECTION 1 – FINDINGS**

1.01 The above recitals are true and correct and are incorporated in this resolution by reference.

### **SECTION 2 – ADOPTION**

**SECTION 5 – SEVERABILITY**

5.01 If a court of competent jurisdiction finds that any section, subsection, sentence, clause, phrase, or provision of this resolution is for any reason invalid or unconstitutional, that provision will be deemed a separate, distinct, and independent provision and will not affect the validity of the remaining portions of the resolution.

**SECTION 6 – EFFECTIVE DATE**

6.01 This resolution takes effect immediately.
