*A Motion was made by Vice-Mayor Carusone, seconded by Commissioner Hanks, to read Ordinance 2017-02 by title only. The Motion carried with the following vote with Commissioner McDowell absent:*

City Clerk Adkins read Ordinance 2017-02 into the record by title only.

City Manager Lewis introduced Public Works Director Bellia who provided an overview of the Ordinance and presented a Power Point. There was no public comment.

Discussion and questions ensued: (1) following a question, Solid Waste Manager Lama confirmed pizza boxes are now able to be recycled; (2) it was stated that Styrofoam containers are not recycle-able, they are a number 6; (3) it was stated that glass is accepted but needs to be rinsed out first; (4) the totes are allowing for more items to be recycled; (5) it was confirmed that we can take anything that is not covered in wax to recycle; (6) bottle caps need to stay on the bottle to be recycled; (7) Section 62-50 of the Ordinance will need to be updated to reflect one side pickup.

***A Motion was made by Vice- Mayor Carusone, seconded by Commissioner Hanks, to continue Ordinance 2017-02 to the Solid Waste District Meeting of April 25, 2017 and have staff review the entire Ordinance to be consistent with the one side pickup program. The Motion carried with the following vote with Commissioner McDowell absent:***
