Good afternoon, Commissioner McDowell,

In response to the below listed questions, attached is a document titled Code Enforcement Lien and Active Violation Information. This is the list of all cases with fines attributed to this property. The amounts NOT in yellow are the actual funds the City paid for contractors to abate the violations and to file the liens. Each case number represents an individual lien, and the lien number and violation category are provided for each case.

There are two cases (Case #19-1296, House Numbers and Case #16-1102, Unsafe Building - Roof) that must be corrected before the house would be considered in compliance with codes.

The <u>Code of the City Section 2-511</u> controls lien reduction and lien release. Lien reductions are not available for any lien for fines imposed after October 25, 2010. Lien Release is only available if the home is in compliance with all codes and if the property owner purchased the property through a foreclosure sale, clerk's sale, or other judicially imposed sale.
