ORDINANCE NO. 2023-29

AN ORDINANCE OF THE CITY OF NORTH PORT, FLORIDA, ESTABLISHING A SCHEDULE AND LOCATION OF CITY COMMISSION REGULAR MEETINGS AND WORKSHOPS FOR THE 2024 CALENDAR YEAR; PROVIDING FOR FINDINGS; PROVIDING FOR CONFLICTS; PROVIDING FOR SEVERABILITY; AND PROVIDING AN EFFECTIVE DATE.

WHEREAS, Section 6.01 of the North Port City Charter requires that the City Commission meet at a time and place as prescribed by ordinance each year; and

WHEREAS, City Commission Policy No. 2021-05 provides that prior to January 1 of each year, the City Commission shall adopt an ordinance establishing the schedule and location of regular meetings and workshops for the calendar year; and

WHEREAS, the City Commission hereby adopts its meeting schedule for the referenced calendar year.

NOW, THEREFORE, BE IT ORDAINED BY THE CITY COMMISSION OF THE CITY OF NORTH PORT, FLORIDA:

SECTION 1 – FINDINGS

- 1.01 The above recitals are true and correct and are incorporated in this ordinance by reference.
- 1.02 In accordance with Florida Statutes Section 166.041(4)(a), the City timely posted a business impact estimate on the City's website on or before the date the newspaper published notice of this ordinance's final reading.

- 2.02 All meetings will take place at/in City Commission Chambers in City Hall, located at 4970 City Hall Boulevard, North Port, Florida 34286, unless otherwise designated by the City Commission.
- 2.03 All workshops will take place in Room 244 located in City Hall at 4970 City Hall Boulevard, North Port, Florida 34286, unless otherwise designated by the City Commission.
- 2.04 By majority vote, the City Commission may cancel or reschedule a meeting identified in this ordinance as long as one meeting is held each month. A meeting is not required to be held in August.

SECTION 3 – CONFLICTS

3.01 In the event of any conflict between the provisions of this ordinance and any other ordinance, in whole or in part, the provisions of this ordinance will prevail to the extent of the conflict.

SECTION 4 – SEVERABILITY

4.01 If a court of competent jurisdiction finds that any section, subsection, sentence, clause, phrase, or provision of this ordinance is for any reason invalid or unconstitutional, that provision will be deemed a separate, distinct, and independent provision and will not affect the validity of the remaining portions of the ordinance.

SECTION 5 – EFFECTIVE DATE

5.01 This ordinance takes effect immediately upon adoption.
