ORDINANCE NO. 2022-05

1 **AN ORDINANCE OF THE CITY OF NORTH PORT, FLORIDA, AMENDING THE CODE OF THE**
2 **CITY OF NORTH PORT, FLORIDA, APPENDIX A – CITY FEE STRUCTURE, SECTION D.**
3 **BUILDING FEES; REPEALING ORDINANCE NO. 2020-28; PROVIDING FOR CONFLICTS;**
4 **PROVIDING FOR SEVERABILITY; PROVIDING FOR CODIFICATION; AND PROVIDING AN**
5 **EFFECTIVE DATE.**

7 **WHEREAS**, the City Commission has the duty, right, power and authority to levy by ordinance and collect
8 fees for city services rendered; and

9
10 **WHEREAS**, the City established a City Fee Structure in the Code of the City of North Port, Florida (“City
11 Code”), Appendix A, Section D, for building fees, as authorized in Florida Building Code Section 109 and
12 Florida Statutes Section 553.80; and

13
14 **WHEREAS**, on July 2, 2020, the City Commission adopted Ordinance No. 2020-28 as a response to the
15 Coronavirus Disease 2019 (COVID-19) pandemic and the Commission’s desire to support local business
16 operations by reducing certain building fees by twenty-five percent (25%); and

17
18 **WHEREAS**, the City Commission has determined that the economic recovery has improved local business
19 operations as intended; and

20
21 **WHEREAS**, the City Commission desires to repeal Ordinance No. 2020-28 and reinstate certain building
22 fees to the fees in effect prior to the adoption of Ordinance No. 2020-28; and

24 **WHEREAS**, the City Commission finds that these amendments serve the public health, safety, and welfare
25 of the citizens of the City of North Port, Florida.

27 **NOW, THEREFORE, BE IT ORDAINED BY THE CITY COMMISSION OF THE CITY OF NORTH PORT, FLORIDA:**

29 **SECTION 1 – FINDINGS**

31 1.01 The above recitals are true and correct and are incorporated in this ordinance by reference.

SECTION 4 – CONFLICTS

4.01 In the event of any conflict between the provisions of this ordinance and any other ordinance, in whole or in part, the provisions of this ordinance will prevail to the extent of the conflict.

SECTION 5 – SEVERABILITY

5.01 If a court of competent jurisdiction finds that any section, subsection, sentence, clause, phrase, or provision of this ordinance is for any reason invalid or unconstitutional, that provision will be

deemed a separate, distinct, and independent provision and will not affect the validity of the remaining portions of the ordinance.

SECTION 6 – CODIFICATION

6.01 In this ordinance, additions are shown as underlined and deletions as ~~striketrough~~. Any additional codification information and notations appear in *italics*. These editorial notations are not intended to appear in the codified text.

SECTION 7 – EFFECTIVE DATE

7.01 This ordinance takes effect immediately upon adoption.
