

**AN ORDINANCE OF THE CITY OF NORTH PORT, FLORIDA, AMENDING THE CODE OF THE CITY OF NORTH PORT, FLORIDA TO ESTABLISH A BUY AMERICAN PREFERENCE, BY AMENDING SECTION 2-402 - DEFINITIONS AND CREATING SECTION 2-421 - BUY AMERICAN PREFERENCE; PROVIDING FOR CONFLICTS; PROVIDING FOR SEVERABILITY; PROVIDING FOR CODIFICATION; AND PROVIDING AN EFFECTIVE DATE.**
