

ORDINANCE NO. 2020-47

An Ordinance of the City of North Port, Florida, Renaming the Neighborhood Development Services Department to Building and Code Enforcement Services and the Activation of the Department of Development & Environmental Affairs; Providing for Conflicts; Providing for Severability; Providing for an Effective Date.

These meetings will be held in the North Port City Chambers, North Port Florida in public session on the date, time and location specified to consider the following Ordinance and proposed passage thereof:
