PROJECT: PVAC-25-03060 Vacation of Easement

REQUEST: Vacate the interior side lot line easement (1,380 SQ.FT) for the platted six-

foot (6') Drainage and Utility Easement located on Lots 32 and 33 of Block

329 of the 5th Addition to the Port Charlotte Subdivision.

APPLICANT: Iurii Covaljiu. (Exhibit A, Warranty Deed and Affidavit)

I. BACKGROUND


On July 17, 2025, the Planning & Zoning Division received an application petitioning the City of North Port to grant a vacation for the platted six-foot (6') Drainage and Utility Easement located on the interior side lot lines of Lots 32 and 33 of Block 329 of the 5th Addition to the Port Charlotte Subdivision.

The purpose of this vacation request is to facilitate a clear title enabling the sale of the property located at 2737 Cottage Ln. The applicant expressed in their request that they were not notified of the easement when they purchased the property, and have found that their home, A/C, pool pump and shed are located on the easement to be vacated. Notably, the original survey submitted with the building permit (20-3382) did not depict the subject easement.

The area to be vacated encompasses $\pm 1,380$ square feet. The subject property is zoned Residential, Low (R-1) with a Future Land Use designation of Low Density Residential. The vacation request was reviewed in accordance with the decision criteria in ULDC Section 2.2.17.B.

II. PROJECT SUMMARY

The property owner is requesting to vacate the interior side lot line easement (1,380 SQ.FT), a platted six-foot (6') Drainage and Utility Easement located on Lots 32 and 33 of Block 329 of the 5th Addition to the Port Charlotte Subdivision to clear the title for the sale of the property.

III. REVIEW PROCESS

The following Utility providers have reviewed the request to vacate the platted interior side lot line utility and drainage easement as per ULDC Section 2.2.17.C and, through written response, have granted approval. (**Exhibit B- Notification to Utility agencies and responses**).

If no response is received within 10 days it is assumed that there is no issue with the vacation of easement.

Conclusion

Based on the responses received, the request to vacate a portion of the rear Six-foot (6') drainage and utility easement meets the following:

- 1. It is a vacation of a public easement.
- 2. The easement is not needed to provide City service to any property.
- 3. No public utilities or City facilities are located or planned to be located in the areas.
- 4. The easement is not necessary to any logical extension of public utility service, sanitary sewer service, drainage or other City services to any property in the future, or an alternate and equally acceptable easement of such extension has been dedicated to the City.

The City Attorney has reviewed the accompanying Resolution No. 2025-R-67 as to form and correctness.

IV. DATA AND ANALYSIS

Chapter 177 of the Florida Statutes provides requirements that regulate and control the platting of lands. Furthermore, Chapter 177.101 of the Florida Statutes lists the actions needed in making an application for vacation of plats either in whole or in part. The individual requesting a partial vacation of plat must give notice of their intention to apply to the governing body to vacate the plat by publishing a legal notice in a newspaper of general circulation in the county in which the tract or parcel of land is located, in not less than two weekly issues of said paper, and must attach to the petition for vacation the proof of said publication, together with proof that taxes have been paid.

2023 Florida Statutes Chapter 177 <u>Findings & Conclusion</u>: The property owners filed a notice of intent to petition the City of North Port to vacate a portion of the platted interior side lot line utility and drainage easement by publishing a legal notice in The Daily Sun newspaper for two weekly issues. (**Exhibit C—Notice of Intent**). Additionally, the applicants provided to the City of North Port Planning and Zoning Division, an application to request a partial vacation of the platted interior side lot line utility and drainage easement, a Publisher's Affidavit, certification that all applicable taxes have been paid, and all other requisite documents (**Exhibit D— Certification of Taxes Paid**). The warranty deed provided to the City as a part of the application established that the applicant owns the fee simple title of the subject property.

Staff concludes that the proposed Petition PVAC-25-03060 is consistent with Florida Statutes Section 177.101.

The Unified Land Development Code (ULDC) contains regulations that govern the development and land use within the incorporated area of the City of North Port, Florida. Chapter 2 of the ULDC, Article II. Development Application Types, Section 2.2.17., Vacations provides procedures for the City to vacate right-of-way, easements, and plats according to the authority granted under the Florida Statutes Chapter 177. In addition, Section 2.2.17.B. includes Decision Criteria for the City Commission to approve a Vacation, as follows:

Decision Criteria. City Commission shall determine whether and the extent to which the vacation:

- (1). Involves land that Is currently occupied by public facilities;
- (2). Necessitates additional easements for future public facilities;
- (3). Impairs or eliminates access to any lot of record;
- (4). Adversely impacts the existing road network or substantially alters travel patterns;

ULDC CHAPTER 2 Development Review

Findings & Conclusion: Staff reviewed the Petition PVAC-25-03060 relative to ULDC Section 2.2.17. Vacations. Pursuant to the provisions in Florida Statutes Chapter 177.101, the property owners did file a notice of intent to apply to the City of North Port Planning & Zoning Division for the vacation of easement in two consecutive weekly issues of The Daily Sun newspaper. Additionally, the applicants provided to the City of North Port Planning and Zoning Division, an application to request a vacation of the platted interior side lot line utility and drainage easement, certification that all applicable taxes have been paid, and all requisite documents.

Upon staff review of the Petition and the responses from utility providers (detailed in Section III above), staff finds that this vacation of easement meets the Decision Criteria per Section 2.2.17.B. of the ULDC as the vacation does not:

- (1). Involve land that Is currently occupied by public facilities;
- (2). Necessitate additional easements for future public facilities;
- (3). Impair or eliminates access to any lot of record;
- (4). Adversely impact the existing road network or substantially alters travel patterns;

Staff concludes that the proposed Petition PVAC-25-03060 is consistent with Chapter 2 of the ULDC.



"While the mediators have made a great effort, Hamas does not appear to be coordinated or acting in good faith," Witkoff said in a statement. "We will now consider alternative options to bring the hostages home and try to create a more stable environment for the people of Gaza."

State Department spokesperson Tommy Pigott would not offer details on what "alternative options" the U.S. is considering to free hostages held by the militant group.

A breakthrough on a ceasefire deal between Israel and Hamas following 21 months of war has eluded the Trump administration as humanitarian

conditions worsen in Gaza. Thursday's move is the latest setback as Trump has tried to position himself as peacemaker and vowed to broker agreements in conflicts from Ukraine to Gaza.

When pressed on whether and how the U.S. would proceed on seeking a truce in Gaza, Pigott did not offer clarity and told reporters that "this is a very dynamic situation."

He said there's never been a question of the U.S. commitment to reaching a ceasefire and faulted Hamas.

The sides have held weeks of talks in Qatar, reporting small signs of progress but no major breakthroughs. Officials have said a main sticking point is the redeployment of Israeli troops after any ceasefire takes

Witkoff said the U.S. is 'resolute" in seeking an end to the conflict in Gaza and



Earlier Thursday, Israeli Prime Minster Benjamin Netanyahu's office recalled his negotiating team in light of Hamas' response. In a brief statement, Netanyahu's office expressed appreciation for the efforts of Witkoff and other mediators Qatar and Egypt but gave no further details.

The deal under discussion was expected to include an initial 60-day ceasefire in which Hamas would release 10 living hostages and the remains of 18 others in phases in exchange for Palestinians imprisoned by Israel. Aid supplies would be ramped up, and the two sides would hold negotiations on a lasting ceasefire.

Teacher charged in double-homicide

No motive given for killing of couple who were with their daughters

LITTLE ROCK, Ark. — Arkansas police charged a 28-year-old school teacher in the killing of a married



couple who were hiking with their

children at Devil's Den State Park, finding him in a nearby city after

a five-day

search and public pleas for trailgoers to look through their photos.

State Police arrested Andrew James McGann at a barbershop in Springdale, said Col. Stacie Rhoads, commander of the department's criminal investigation division. He was charged with two counts of capital murder and was being held Thursday in the state's Washington County

Police announced the arrest at a Wednesday night news conference but would not discuss a motive. McGann had been hired at Springdale Public Schools as a teacher candidate for the upcoming year but had not yet come into contact with any of its families or students, the district said in a statement.

A lawyer couldn't be located for McGann, and a message was left for a number listed for him. It was not immediately clear when his first court appear-

"If you commit a violent,

senseless act here in our state, our law enforcement will hunt you down and bring you to justice, because that's what the people of Arkansas frankly deserve," Arkansas Gov. Sarah Huckabee Sanders told reporters.

Springdale is roughly 30 miles (48.28 kilometers) north of the state's remote Devil's Den park, where trails have remained closed since Saturday's killings.

Clinton David Brink, 43, and Cristen Amanda Brink, 41, were found dead on a walking trail at Devil's Den. Their daughters, who are 7 and 9, were not hurt and are being cared for by family members, authorities have said.

Police had released a composite sketch and photo of a person of interest they were searching for in the attack.

The State Police have released few details about the investigation, including how the couple was killed. Rhoads said the public's help and video footage they received was instrumental in capturing McGann. Tips came in from as far away as Washington state, she said.

"It was overwhelming," she said.

Jared Cleveland, the superintendent of Springdale Public Schools, said in a statement that McGann had not yet begun his employment and that the district could not provide more information, citing the investigation.

"Our entire team extends our deepest condolences to the Brink family. Their children are especially in our thoughts and prayers," Cleveland said.

Sierra Marcum said three years ago, her son

was a student in McGann's fourth grade classroom in Flower Mound, Texas, and described him as the "most standoff teacher she had ever met." Her son's yearbook includes a photo of McGann.

"Pretty cold. You could ask him a question and he would give you a one word response," she said. "Overall just pretty disinterested in his students."

Clinton and Cristen Brink had just moved from South Dakota to the small city of Prairie Grove in northwest Arkansas. Their water had been connected less than two weeks ago,

Mayor David Faulk said. Clinton Brink had been scheduled to start a job as a milk delivery driver Monday in the nearby Fayetteville area, according to Hiland Dairy, his employer. Cristen Brink had been licensed as a nurse in Montana and South Dakota before moving to Arkansas.

The Brink family said the couple died "heroes protecting their little girls."

"Our entire state is grieving for the tragic loss and senseless and horrific crime that's taken place in this area," Sanders said.

Devil's Den is a 2,500acre (1,000-hectare) state park near West Fork, about 140 miles (220 kilometers) northwest of Little Rock, the state capital.

The park is known for its hiking trails and rock formations, and it is a short drive from the University of Arkansas in Fayetteville and Walmart's Bentonville headquarters.

It was selected as a state park site in the 1930s and the park's trails lead to the surrounding Ozark National Forest.
