ORDINANCE NO. 2022-17

1 **AN ORDINANCE OF THE CITY OF NORTH PORT, FLORIDA, AMENDING THE CODE OF THE**
2 **CITY OF NORTH PORT, FLORIDA, APPENDIX A – CITY FEE STRUCTURE, TO CHANGE**
3 **CERTAIN FIRE RESCUE, PARKS AND RECREATION, FACILITY RENTAL, AND UTILITIES FEES;**
4 **PROVIDING FOR FINDINGS; PROVIDING FOR CONFLICTS; PROVIDING FOR**
5 **SEVERABILITY; PROVIDING FOR CODIFICATION; AND PROVIDING AN EFFECTIVE DATE.**

7 **WHEREAS**, the City Commission has the duty, right, power, and authority to levy and collect fees for City
8 services rendered; and
9

10 **WHEREAS**, the City’s fees provide funding for the purpose of providing services to the residents of the
11 City of North Port; and

13 **WHEREAS**, the City Fee Structure is codified as Appendix A to the Code of the City of North Port, Florida;

16 **WHEREAS**, the City Commission finds that these amendments serve the public health, safety, and welfare
17 of the citizens of the City of North Port, Florida.

19 **NOW, THEREFORE, BE IT ORDAINED BY THE CITY COMMISSION OF THE CITY OF NORTH PORT, FLORIDA:**

21 **SECTION 1 – FINDINGS**

23 1.01 The above recitals are true and correct and are incorporated in this ordinance by reference.

Warm Mineral Springs Refund Policy:	
Tickets are not refundable, cannot be exchanged, and are not transferable. Same day re-entry shall be permitted. Proof of residency required; no rainchecks allowed. If the City closes Warm Mineral Springs due to facility issues, construction, or inclement weather, patrons in the facility at the time of the facility closure will receive an admission voucher good for one entry to the Springs within 30 days of the closure. Rainchecks will be provided for patrons in the facility who experience a closure due to facility issues, wildlife or inclement weather if they have been at the facility for less than two	

hours and the closure is expected to last more than one hour. Receipt of purchase required. Raincheck will be valid for six months of the date of closure.

65 3.01 In the event of any conflict between the provisions of this ordinance and any other ordinance, in

66 whole or in part, the provisions of this ordinance will prevail to the extent of the conflict.

68 **SECTION 4 – SEVERABILITY**

70 4.01 If a court of competent jurisdiction finds that any section, subsection, sentence, clause, phrase,

71 or provision of this ordinance is for any reason invalid or unconstitutional, that provision will be

72 deemed a separate, distinct, and independent provision and will not affect the validity of the

73 remaining portions of the ordinance.

75 **SECTION 5 – CODIFICATION**

77 5.01 In this ordinance, additions are shown as underlined and deletions as ~~striketrough~~. Any

78 additional codification information and notations appear in *italics*. These editorial notations are

79 not intended to appear in the codified text.
