NPPD:

- **Missing** in Q&A - 1H 43M -- **Bravo Commander org chart position responsibilities**
- Clarification and **MISSING**: starting at 2H 13M through 2H 24M mark -- **There was consensus to postpone Budget Proposal #2206 for an Accreditation Specialist position to be reviewed next fiscal year.**

There was a reconsideration of the consensus vote at the 2H 19M mark. **A consensus to keep the BP #2206 to the Accreditation Specialist position for this FY 2022/23.** (Vote 4-1 with DM dissenting). City Clerk confirmed all of the consensus taken for the NPPD at the 2H 24M mark.

- **Formatting or missing** services under Fleet Management, backflow copies, utilities repairs, water treatment plant chemicals, **consensus to cut the BP #2160 part-time Customer Service Representative position failed** (5H 50M mark), empowering employees,
