On March 28, at 1728 hours, I was dispatched to 6207 West Price Blvd, North Port, Florida reference multiple people fighting in the aquatic center.

Upon arrival it was discovered there had been only two juveniles involved. I spoke to the complainant [REDACTED] who explained the two juveniles had been involved in a verbal dispute which became physical between them in the city park. The complainant said they would handle the situation and requested a trespass from the park on both juveniles.
