RESOLUTION NO. 2017-R-23

A RESOLUTION OF THE CITY COMMISSION OF THE CITY OF NORTH PORT, FLORIDA, AS THE GOVERNING BODY OF THE NORTH PORT SOLID WASTE DISTRICT ESTABLISHING NOT-TO-EXCEED NON-AD VALOREM ASSESSMENT RATES FOR THE NORTH PORT SOLID WASTE DISTRICT FOR THE 2017-2018 FISCAL YEAR, CONFIRMING PARTICIPATION IN SARASOTA COUNTY TRIM NOTICE AND NOTICE OF PROPOSED TAXES, PROVIDING FOR CONFLICTS, PROVIDING FOR SEVERABILITY AND PROVIDING AN EFFECTIVE DATE.

WHEREAS, the 2017-2018 fiscal year proposed budget for the North Port Solid Waste District contemplates no rate increase, and

WHEREAS, the District wishes to provide said notice through the Sarasota County TRIM Notice and Notice of Proposed Taxes.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COMMISSION OF THE CITY OF NORTH PORT, FLORIDA, SERVING AS THE GOVERNING BODY OF THE NORTH PORT SOLID WASTE DISTRICT, TO WIT:

SECTION 1 SOLID WASTE DISTRICT RATES

- 1.01- The City Commission hereby establishes \$249.00 as the not-to-exceed rate for each residential unit for the North Port Solid Waste District for the 2017-2018 fiscal years, as further described in Section 66-91(b). The 2017-2018 fiscal years begins October 1, 2017, and ends September 30, 2018.
- 1.02- The City Commission hereby authorizes staff to notify property owners of the rate by participation in the Sarasota County TRIM notice and Proposed Notice of Taxes.
- 1.03- The City Commission hereby clarifies the rate is established only as a not-to-exceed rate and this section does not officially adopt any rate for the 2017-2018 fiscal year.

SECTION 2 CONFLICTS

2.01- If there is any conflict between the provisions of this Resolution and any other resolution or ordinance or portions thereof, the provisions of this Resolution shall prevail to the extent of such conflict.

SECTION 3 SEVERABILITY

3.01- If any section, subsection, sentence, clause, phrase or portion of this Resolution is for any reason held invalid or unconstitutional by any court of competent jurisdiction, such portion shall be deemed a separate, distinct, and independent provision and such holding shall not affect the validity of the remaining portions.

SECTION 4 EFFECTIVE DATE

4.01 - This Resolution shall take effect immediately upon adoption.
