

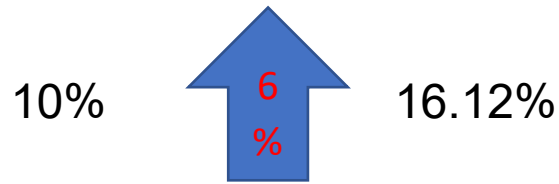

Thus...

In order to fairly represent the increase of non-residential area proposed on the new Official Zoning Map, the existing non-residential acreage is reduced by the percentage increase in the drafted acreage (61%) resulting in the apples to apples comparison showing a functional increase of 12%.
