**ART ADVISORY BOARD
MINUTES OF REGULAR MEETING
MONDAY, FEBRUARY 11, 2019**

Present: Josh Reid, Chair; Moira Powell; Zhaneta Albritton, Youth Member; Shawn Singh, Youth Member; Staff Liaison Katrina Romano, Neighborhood Development Services Administrative Manager; and Recording Secretary Hale.

Absent: Laura Pucci.

The Regular Meeting of the Art Advisory Board was called to order at 6:00 p.m. in Meeting/Training Room 244 by Chair Reid.

The Pledge of Allegiance was led by the Board.

3. PUBLIC COMMENT

There was no public comment.

4. ELECTION OF VICE-CHAIR

Due to the resignation of Lauren Almarode, elections for a new Vice-Chair was required.

Chair Reid nominated Laura Pucci as Vice-Chair of the Art Advisory Board; seconded by Board Member Albritton. There were no other nominations and the motion carried unanimously.

5. MINUTES APPROVAL: FOR JANUARY 14, 2019 REGULAR MEETING

Board Member Powell moved that the Art Advisory Board approve the January 14, 2019 Regular Meeting Minutes as presented; seconded by Board Member Albritton. The motion carried unanimously.

6. ISSUES TO BE DISCUSSED (UNFINISHED BUSINESS)

6A Call to Artist update

Board Liaison Romano reported: 1) an email was created and posted on the City's website for the Call-to-Artists submissions listing the criteria; 2) there were some inquiries but so far no official submittals have been received; 3) an entity inquired whether the Board wanted to advertise its Call-to-Artists on Art Show.com, which would cost \$25.00 for an ad on their website; 4) after a concern, it was determined that because funds for ads are not in the Board's budget, approval from the City Manager to expend funds to purchase ad is needed; 5) the deadline for artists' submissions is March 5, 2019; 6) the Call-to-Artists will be reposted on the City's social media pages; 7) if the project does not attract an artist, new solutions will be discussed; 8) after it was suggested that the Board could hire someone, clarification was provided that the City's procurement process would have to be followed and the Commission will have to be apprised.

6B Board Recruitment

Chair Reid announced that Lauren Almarode recently resigned and the Board now has four openings for Regular members and encouraged Board Members to recruit in their circles of influence.

6C Arts at the Hall update

Chair Reid: 1) dropped off 38 pieces of artwork from five schools to the framer, which will be ready by March 7, 2019; 2) he will bring the artwork to City Hall on Friday, March 8, 2019 to be hung on the second and third floors; 3) cards with student names, school grade and title of work will be needed for the art as well as Certificates of Participation for each student; 4) teachers will be contacted to obtain the names of the students; 5) the art pieces will not be juried; 6) certificates will be presented around 11:00 a.m. on Saturday and Chair Reid will create and forward a flyer to the art teachers with this information; 7) Parks & Recreation Supervisor Jonathan Wheatley will be contacted regarding who is responsible to purchase supplies; 8) cookies and juice will be purchased from the Art Board Budget; 9) Ms. Almarode was to contact groups to perform and because of her resignation, Board Member Albritton volunteered to find entertainment for the second floor.

Liaison Romano explained that the art hanging system needs new anchors before pictures may be hung and they are in the process of being ordered. It is anticipated they will be in place prior to artwork being hung in City Hall.

6D Teacher feedback pertaining to Commission request for entertainment between district and regular meetings

Discussion ensued: 1) the entertainment is scheduled between 5:30 p.m. to 6:00 p.m., when the District Meetings end and the Commission Meeting begin; 2) Board Member Albritton reported that Universal Dance was unable to come in January but will be contacted again for the February 26, 2019 meeting and will email Ms. Romano when it is confirmed.

4) Your Project



My proposal is a steel sculpture of a Roseate Spoonbill - *Platalea ajaja*, wings spread, landing on the top of a branch. It will be fabricated from welded steel and powder coated to reproduce the bird's natural pink coloration. The spoonbill will be larger than life size with an approx. 6-7 foot wingspan and measuring 10-12 feet tall including the tree it's landing on which serves as the support.

The spoonbill will be constructed from welded mild steel and powder coated. Powder coating is an industrially applied process that creates a hard finish tougher than conventional paint. It has very excellent corrosion resistance, low maintenance and high durability. Maintenance will be virtually nil, other than occasional cleaning to remove dust/leaves/bird droppings.

The sculpture will be fabricated using precise technology and sound fabrication methods. It will be incredibly strong, durable, weatherproof and safe for human interaction.

The safety and well-being of visitors is the fundamental priority when designing a public piece. To ensure the highest level of safety, all construction will be secure and permanent with no sharp edges or loose parts.

This work is complete and ready for installation. 66 X 35 X 16 approx 150 lbs and equipped with steel eye screws to secure to a concrete pad. Placement is bolted to a concrete pad. Maintenance is minimal with and occasionally mild soap and hose water. I would not recommend pressure washing or harsh chemical cleaners. Materials are exterior grade cement, steel and stains with an all weather sealant

I would not recommend pressure washing or harsh chemical cleaners. Materials are exterior grade cement, steel and stains with an all weather sealant.

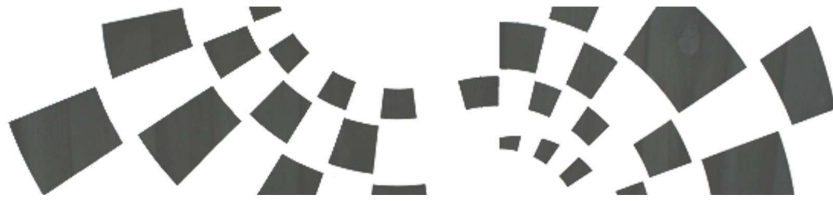

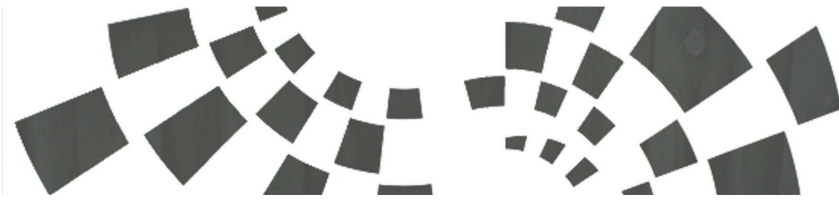
About the Fabrication

The sculpture will be created using the latest technology available in metal fabrication. The fabrication will be processed at my shop located in Miami. After completion of the engineering process and shop drawings are generated, we will buy the specific materials from our Florida suppliers who guarantees next day delivery.

The process: After the materials are received, the machinery is setup to laser/waterjet cutting the sheet metal. Some metals will be rolled or bended according to the specific design. We will then, transport the metals to the welding and assemblage area, where the parts will be sanded. We then, perform a test of assembly of the whole sculpture. Lastly, we prime the metals and apply final painting.

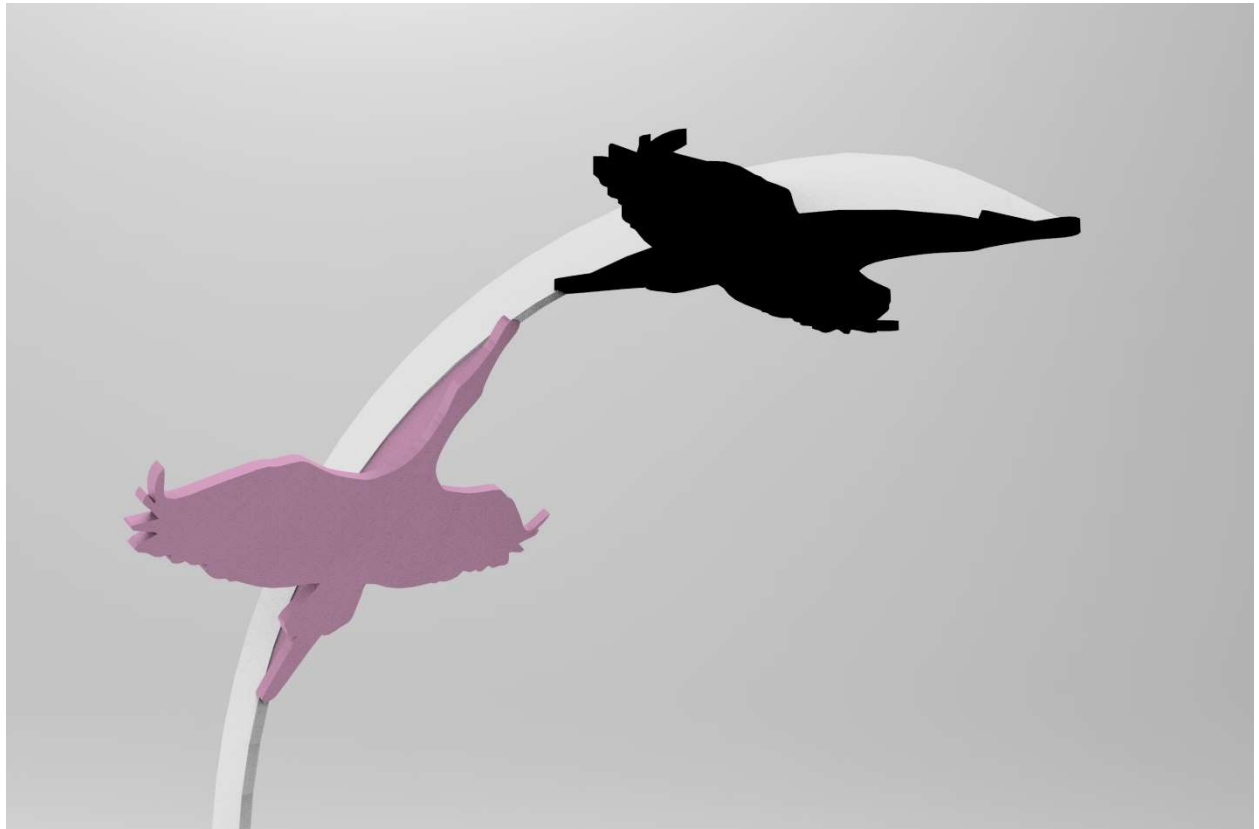

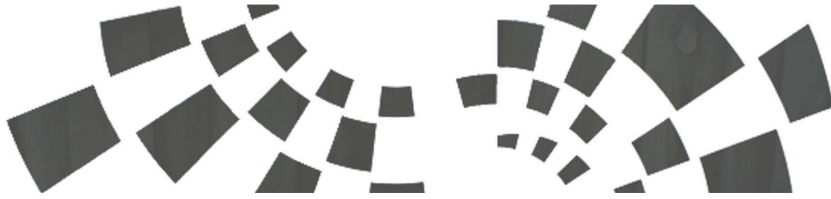

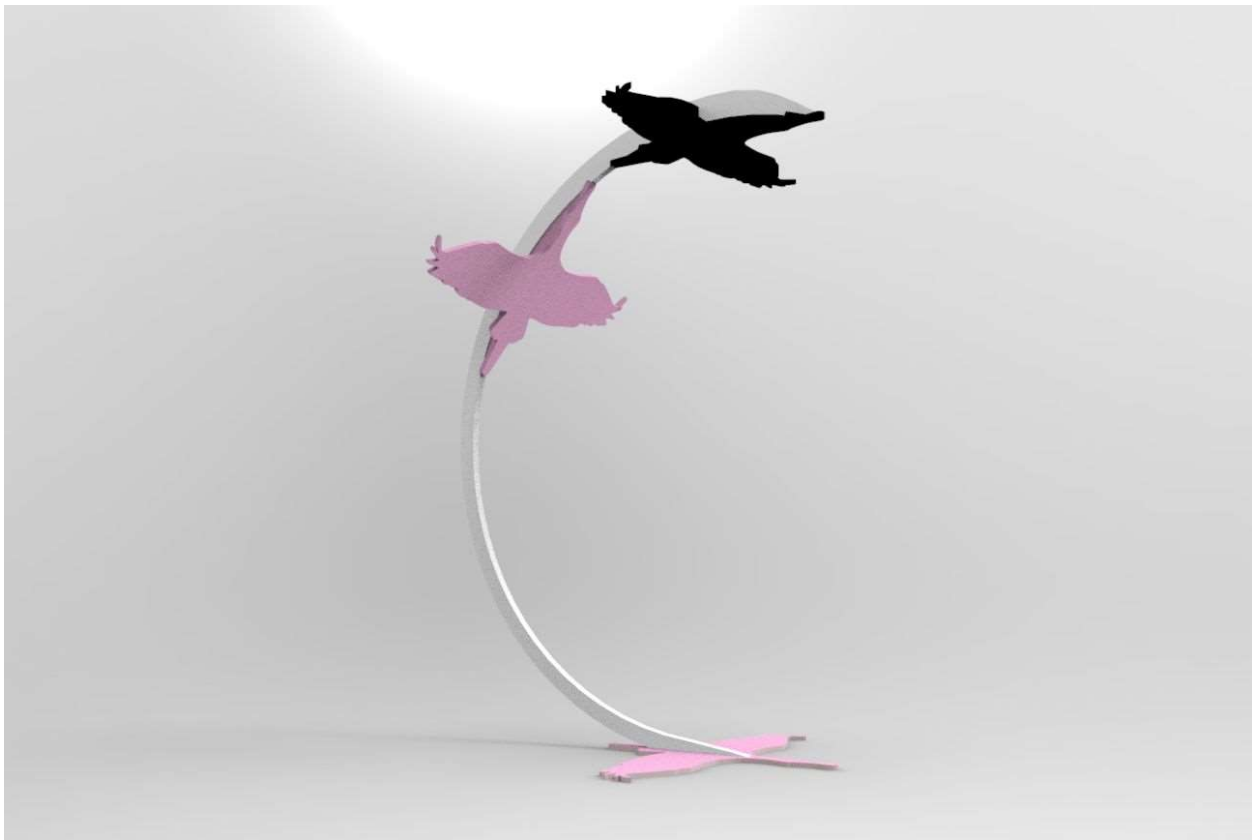
Maintenance

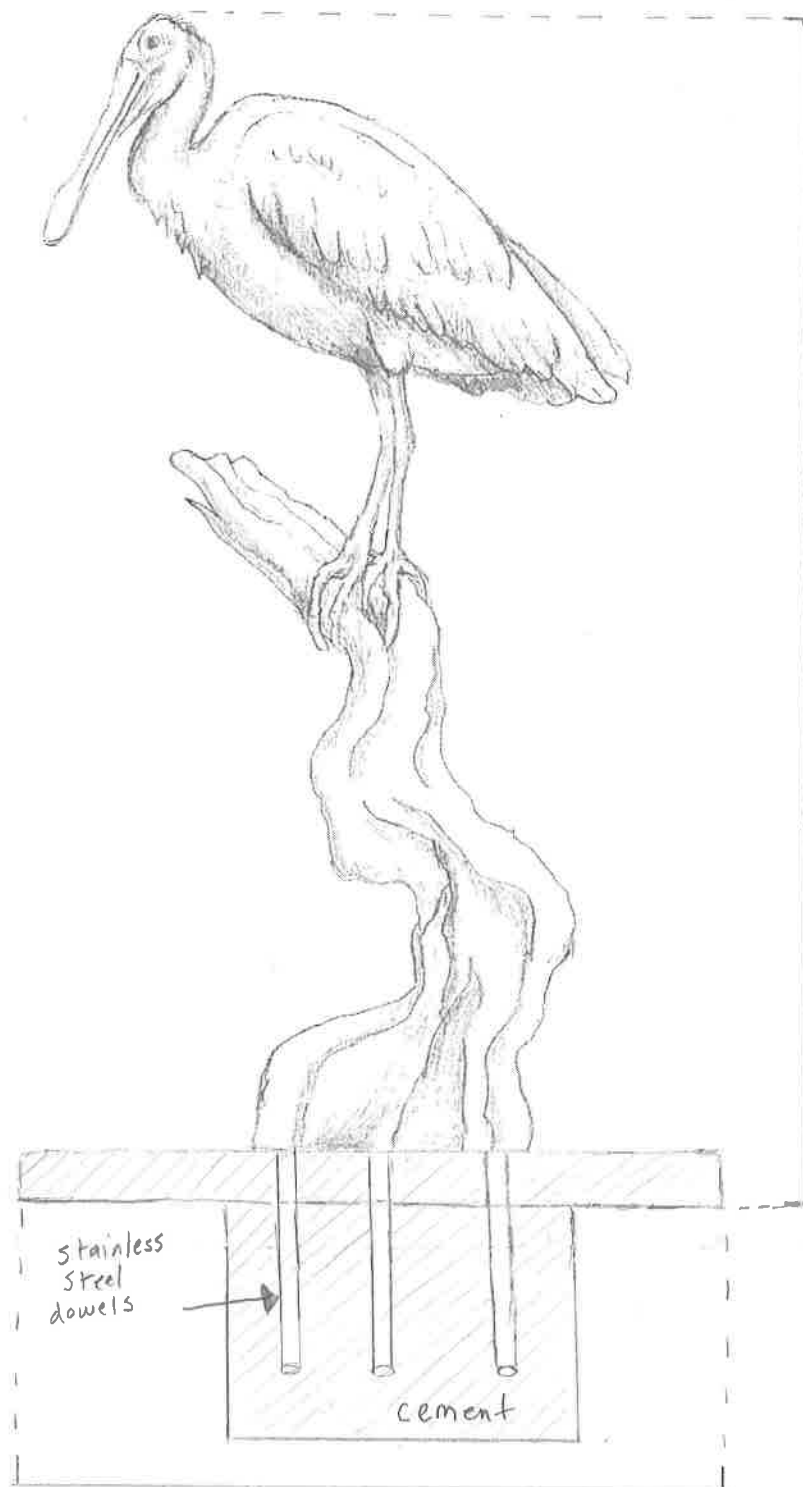
Description:

The bronze Roseate Spoonbill would be perched on a steel-reinforced cement stand sculpted as a driftwood branch. The Roseate Spoonbill would be sculpted in clay then translated into bronze using the lost wax casting method. It would be welded to a steel structure encased in the "driftwood branch" serving as a stand. The steel structure would extend down through the stand into the cement footer secured by 12" stainless steel dowels. The installation will be permanent and involve the use of carefully drilled holes, stainless steel rods that fit into those holes and a suitable, injected construction epoxy.

Maintenance:

By using bronze and cement the maintenance on this sculpture would be minimal. Outdoor bronze sculptures should be cleaned with soap and water and waxed with Carnauba wax once a year. The cement base will not need any maintenance.

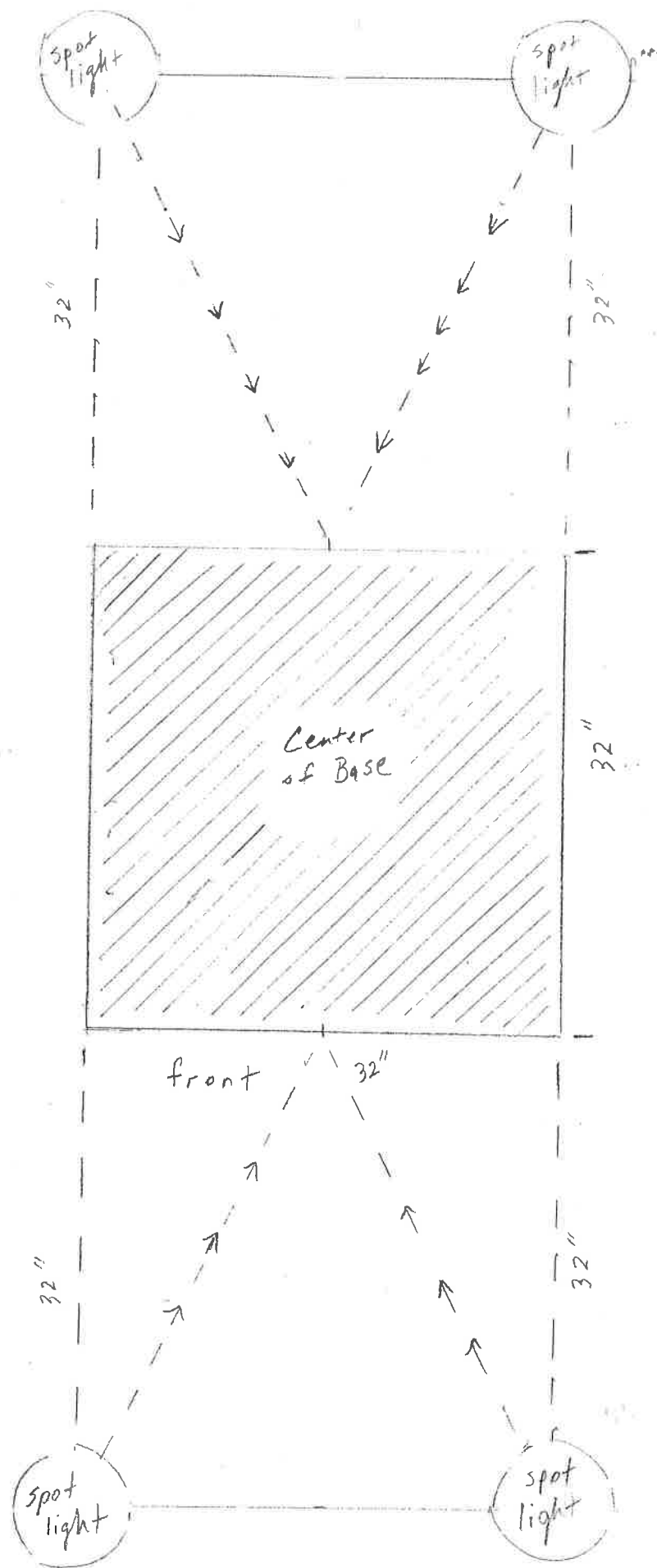

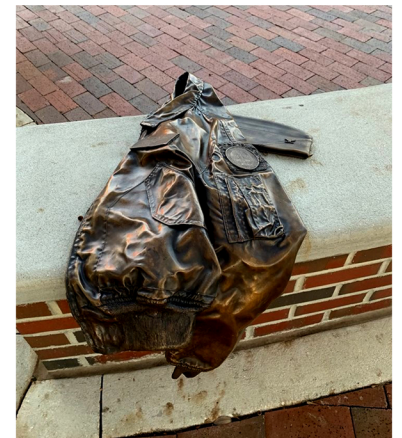

4. Project Description

Dual Fabrication, Artist Collaboration

Project Description

Inspired by the Great Horned Owl of Florida, we would like to propose a sculpture entitled *Catching Flight* for the corner of Price Blvd. and Sumter Blvd. in North Port, Florida. Easily identified by their ear-like tufts, large yellow eyes, sharp talons, and deep hooting voice, great horned owls are well-known for their fierce nature and ability to catch prey larger than themselves.

We are an artist team entitled *Dual Fabrication, Artist Collaboration* which is composed of two people, Courtney N. Ryan and Chris W. Horne. With over 30+years of combined experience in the arts, we are confident we can provide North Port, Florida with an iconic, landmark sculpture for the corner of Price Blvd. and Sumter Blvd.

Our sculpture *Catching Flight* is representative of a great horned owl in midflight, perhaps catching prey or coming in for a landing with its expansive, lightweight wings abreast in the air. We wanted to emphasize the lightweight nature of the bird with a sculpture that mimicked the owls hollow, internal skeletal structure while still abstracting the form enough to relate to the delicate external feathers of a great horned owl. Powder coated with architectural-grade coating to protect from the elements, this sculpture sits atop a 4'x 4' pedestal that tapers to a 2'x2' top and measures 7' tall. Pedestrians will gaze slightly upward at the piece which weights approximately 1100-pounds and is mounted to the surrounding pathway with appropriate anchors. Vehicles will also have the opportunity to view the sculpture from afar as they approach the intersection.

Fabricated from stainless steel, glass fiber reinforced concrete, and powder coated aluminum, the sculpture is modular and can be installed on site with ease used a locking-bolt system and anchors to the surrounding concrete pathway/slab. Additionally, a set of cast-glass eyes will be installed in *Catching Flight* to represent the piercing eyes of great horned owl. Lighting will be placed around the piece in a ring or square to highlight the work throughout the night and illuminate the cast glass eyes with a subtle glow and further emphasize the owl's nocturnal presence.

We look forward to the opportunity to work with the city of North Port, Florida on creating a permanent landmark sculpture for the corner of Price Blvd. and Sumter Blvd in the near future. 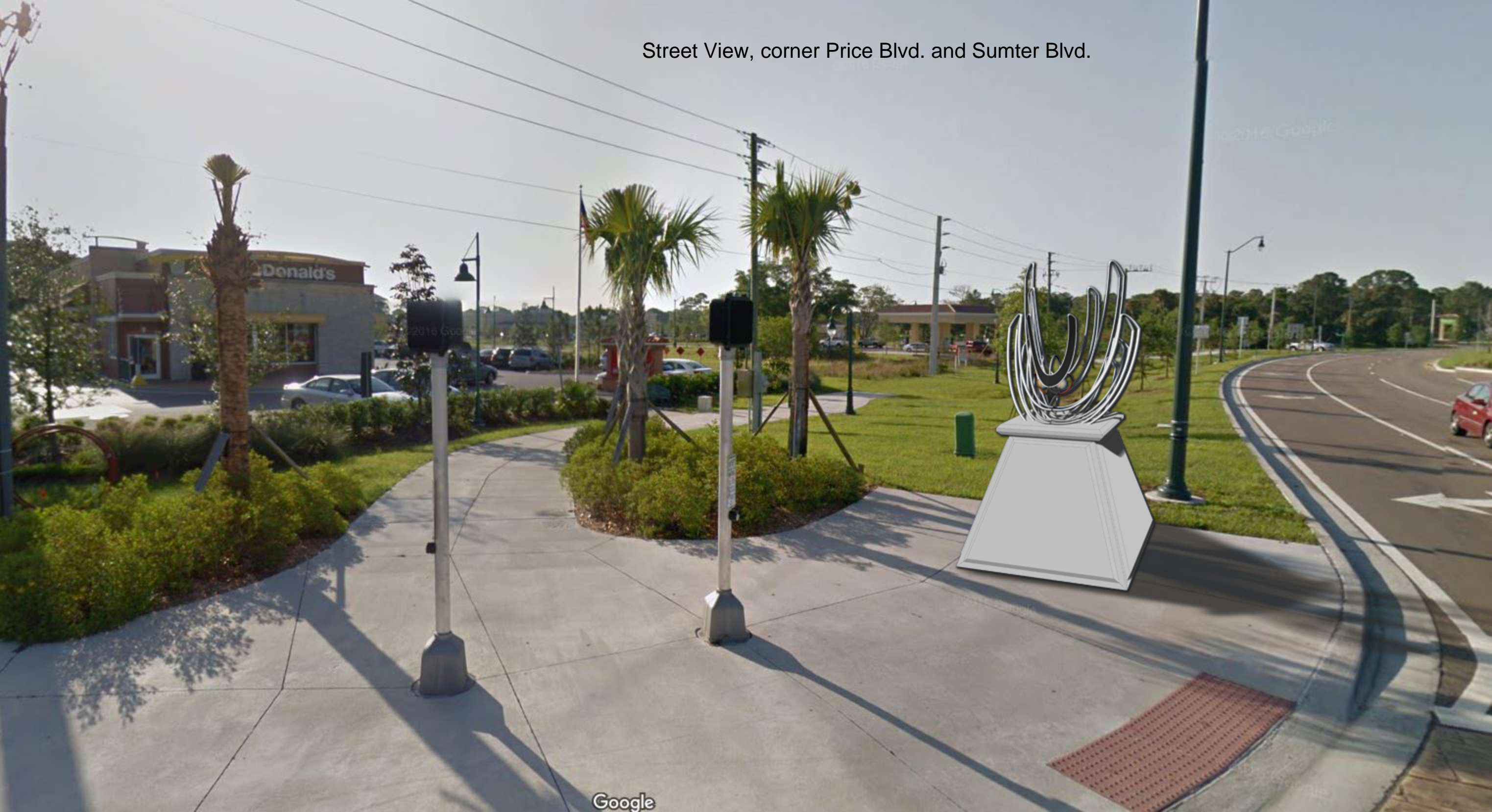

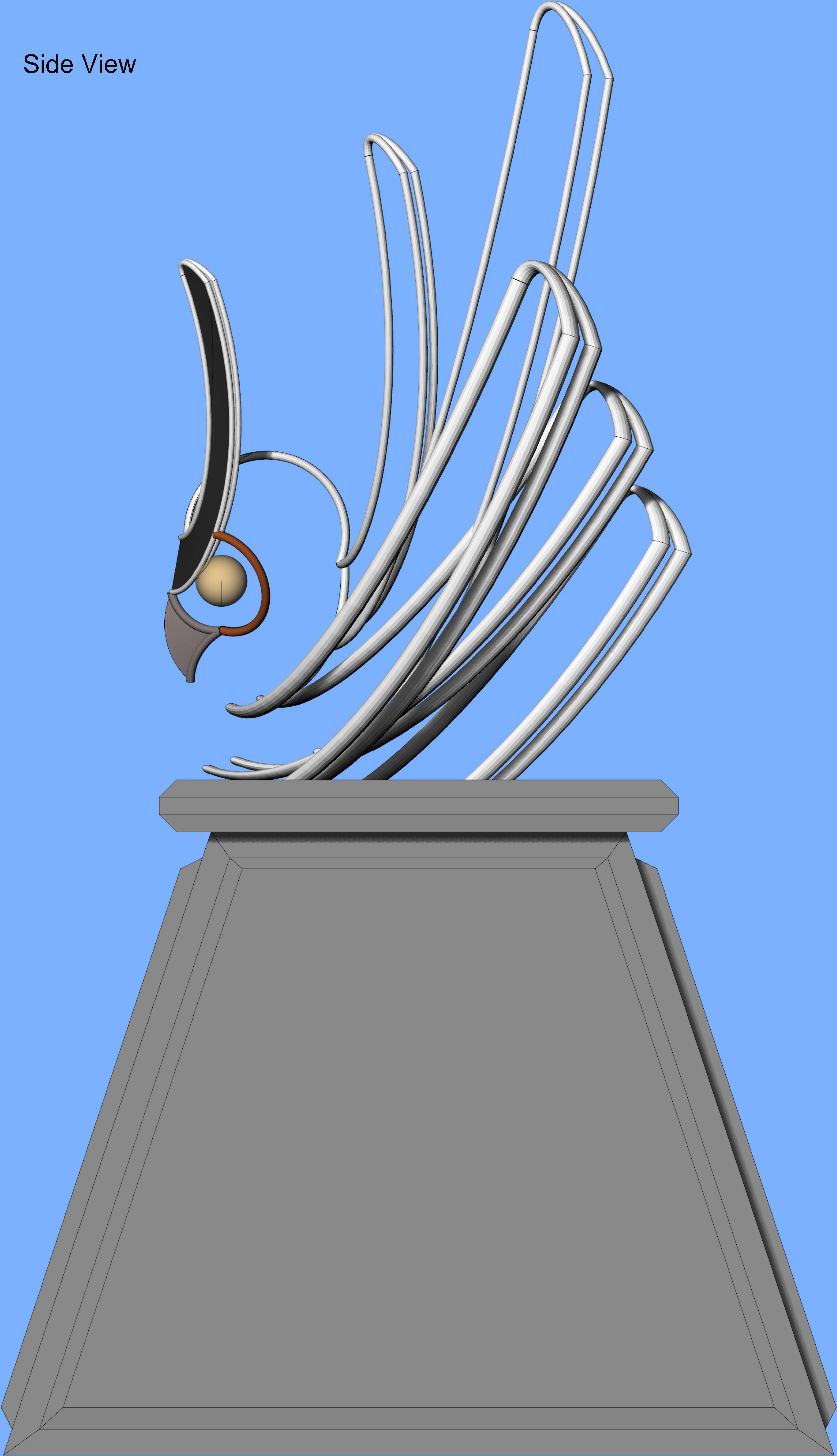

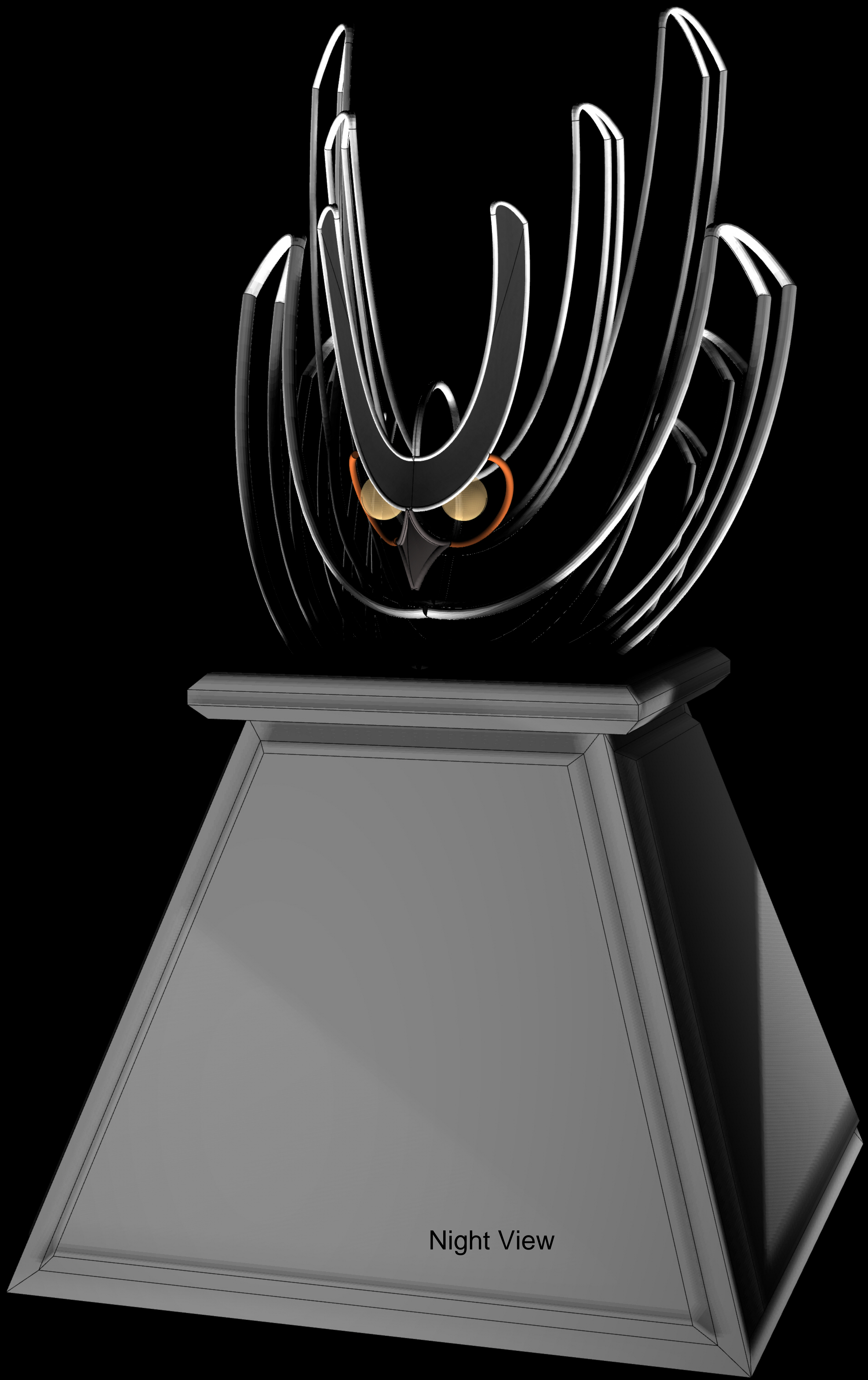


Street View, corner Price Blvd. and Sumter Blvd.

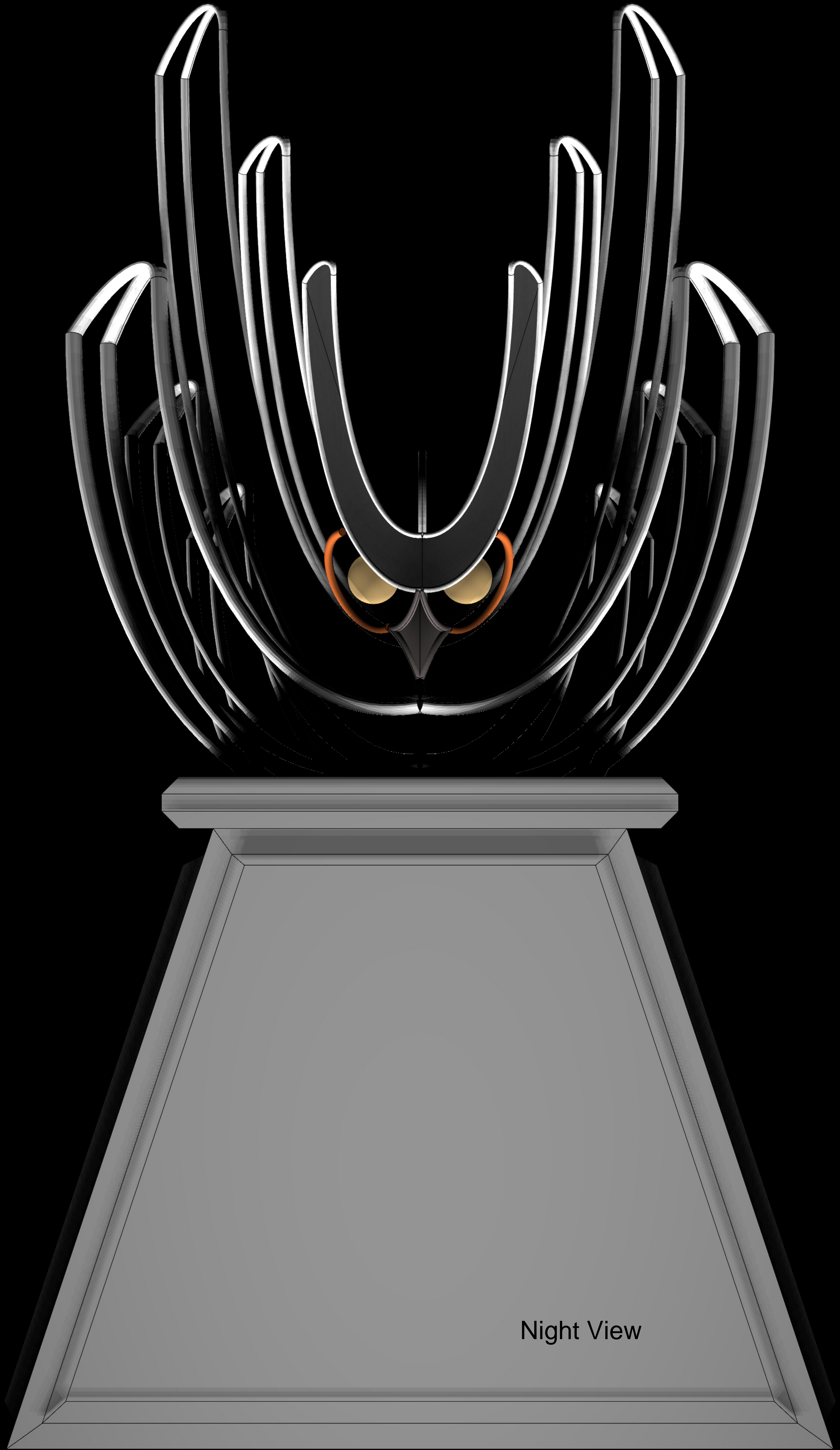


Side View

RE: Art Fund

On January 3rd, 2018, Commissioners heard a presentation from the Communications Division regarding a Mural at the North Port Senior Center. Previously, staff has been directed to come back to Commissioners with costs of murals completed in the City of Punta Gorda. The costs of the murals came back between \$25,000 to \$35,000.

After receiving those numbers, Commissioners directed staff to come back with how much money was available in the City's Art Fund. Currently the Art Fund contains \$111,931.65. Of this, \$16,000 is reserved for Walgreens at Heron Creek, so the amount available to spend is \$95,931.65. These numbers were requested from and for Commissioners to review before moving forward and planning a possible public charette on the issue.

It should be noted that the Art Fund can be utilized for the purposes discussed, (Senior Center mural) but expenditures need to be approved by City Commission. The Art Advisory Board provides recommendations on placement of artwork in public spaces. See Admin Code 4-122.

Staff needs Commission to request this item to be placed back on an upcoming agenda if they would like to discuss the usage of these funds and provide further direction on the mural project and possible charette.
