

**FIRST AMENDMENT TO THE
AMENDED AND RESTATED
REQUESTED OPERATIONAL ASSISTANCE
AND
VOLUNTARY COOPERATION AGREEMENT**

This FIRST AMENDMENT TO THE AMENDED AND RESTATED REQUESTED OPERATIONAL ASSISTANCE AND VOLUNTARY COOPERATION AGREEMENT entered into by, between and among the following law enforcement agencies located in Sarasota and Manatee counties: Town of Longboat Key Police Department; City of North Port Police Department; City of Venice Police Department; City of Sarasota Police Department; Sarasota County Sheriff's Office; Sarasota-Manatee Airport Authority; New College of Florida Board of Trustees; and, Sarasota County Schools Police Department with an effective date of January 1, 2021, and which was previously renewed for three years with a current expiration date of through and including December 31, 2026, is amended to clarify the extra jurisdictional powers conferred by the Agreement.

WITNESSETH

WHEREAS, the parties entered into an Amended and Restated Requested Operational Assistance And Voluntary Cooperation Agreement with an effective date of January 1, 2021; and

WHEREAS, the Amended and Restated Requested Operational Assistance and Voluntary Cooperation Agreement was renewed by the parties for a period of three years through and including December 31, 2026; and

WHEREAS, in light of recent case law, the parties wish to amend the Agreement to clarify the extra jurisdictional powers conferred by the Agreement.

NOW, THEREFORE, in consideration of the foregoing and the covenants hereinafter contained, it is agreed among the parties to amend the Agreement as follows:

1. The foregoing recitals are true and correct and are incorporated herein by reference.
2. Section 2, Voluntary Cooperation, Paragraph A, is hereby amended to clarify the extra jurisdictional powers conferred by the Agreement. As amended, said Section 2, Paragraph A, shall provide as follows:

A. Notwithstanding any limitation on the authority of an officer to act outside his or her jurisdiction, each party agrees that if an officer from one jurisdiction is conducting an investigation regarding any crime, or to comply with the provision of § 316.1932 regarding breath, urine, and/or blood tests, for an offense that occurred within the officer's jurisdiction, the officer and all other officers from the same agency retain jurisdiction to continue the investigation outside their jurisdictional limits. The officer or officers may, at any time, perform any investigative function related to the investigation, including but not limited to the collection of evidence and suspect interviews, and exercise all law enforcement powers outside of their jurisdiction as it pertains to that investigation. Unless circumstances exist which necessitate immediate law enforcement action, an officer anticipating the arrest of subject(s) or continuing the investigation outside of his or her jurisdiction shall report the location and nature of the investigation to on-duty supervision of the agency with jurisdiction, which shall be provided with an opportunity to respond prior to law enforcement action being taken.

3. Except as expressly set forth herein, all of the terms and conditions of Amended and Restated Requested Operational Assistance and Voluntary Cooperation Agreement, as previously extended, are hereby ratified and confirmed by the parties, and each by the execution of this First Amendment hereby signifies their intent to be bound thereby.

4. This First Amendment to the Agreement may be executed in a number of identical counterparts which, taken together, shall constitute collectively one (1) agreement; but in making proof of this First Amendment to the Agreement, it shall not be necessary to produce or account for more than one such counterpart.
