## CALL TO ORDER/ROLL CALL – JACQUELINE MOORE, MAYOR

The Fire Rescue District Governing Body Special Meeting Budget Hearing was called to order at 6:43 p.m. in City Chambers by Mayor Moore.

Present: Mayor Moore; Vice-Mayor DiFranco; Commissioners Cook, Jones, and Yates; City Manager Lewis; City Attorney Moriarty; City Clerk Adkins; Recording Secretary Hale, and Police Chief Vespia.

#### APPROVAL OF AGENDA – COMMISSION

A motion was made by Commissioner Jones, seconded by Vice-Mayor DiFranco, to approve the agenda as presented. The motion carried by the following vote:

- A. <u>16-0527</u> Second Reading of Ordinance No. 2016-29, Adoption of Fiscal Year 2016-2017 Fire Rescue District Budget.

City Clerk Adkins read Ordinance No. 2016-29 into the record by title only, and City Manager Lewis provided a brief review, stating that the proposed budget for the Fire Rescue District is \$9,141,690 and represents a decrease of 3.5% in the assessment rates over the prior year's rate. Combined with the Emergency Medical Services, the total budget is \$13,584,020. Public comment was held.

Following a request, City Manager Lewis confirmed that the rates adopted by Resolution No. 2016-R-25 on September 8, 2016 and this Ordinance is for the allocation of funding that those rates bring in.

A motion was made by Commissioner Yates, seconded by Commissioner Jones, to approve Ordinance No. 2016-29, Adoption of Fiscal Year 2016-2017 Fire Rescue District Budget. The motion carried by the following vote:
